# PRESENT,

The KING's Most Excellent Majesty in Council.

WHEREAS the Department of Health for Scotland have, in pursuance of the powers competent to them under the Burial Grounds (Scotland) Act, 1855, made a Representation that they have received a copy of an Interlocutor, dated 7th June 1933, pronounced by the Sheriff-Substitute of Fife and Kinross, at Kirkcaldy, finding that the old Churchyard of Auchtertool Parish, situated about a mile to the west of the village of Auchtertool, is in a condition which is offensive and contrary to decency:

And whereas in the said Representation it is recommended that Burials be forthwith discontinued in the said Churchyard, in terms of Section 5 of the aforesaid Act, except for the reservation of a right of burial in the said Churchyard in the cases of:—

- (1) Spouses of parties interred in the said Churchyard;
- (2) Unmarried daughters whose parent or parents are already interred therein; and
- (3) The Reverend J. S. W. Irvine, The Manse, Auchtertool, and his wife, Mrs. James Irvine.

And whereas by an Order in Council of the 21st day of December 1933 Notice of such

Representation was given and it was ordered that the same should be taken into consideration by a Committee of the Privy Council on the 3rd day of February 1934, and that the said Order, or Notice thereof, should be published in the Edinburgh Gazette, and that copies of the said Order or Notice thereof should be fixed on the doors of the Church of, or on some other conspicuous places within, the parish or parishes affected one month before the said 3rd day of February 1934:

And whereas Notice of the said Representation and of the time when it pleased His Majesty to order the same to be taken into consideration by the Privy Council has been duly published in the Edinburgh Gazette, and fixed in manner required by the said Order in Council:

Now, therefore, His Majesty, by and with the advice of His Privy Council, is pleased to order, and it is hereby ordered, as follows, viz.:—

That burials be forthwith discontinued, in terms of Section 5 of the Burial Grounds (Scotland) Act, 1855, in the old Churchyard of Auchtertool Parish, situated about a mileto the west of the village of Auchtertool, except for the reservation of a right of burial in the said Churchyard in the cases of:—

- Spouses of parties interred in the said Churchyard;
- (2) Unmarried daughters whose parent or parents are already interred therein; and

(3) The Reverend J. S. W. Irvine, The Manse, Auchtertool, and his wife, Mrs. James Irvine.

Provided always as regards future interments that the exercise of the right of burial be not injurious to public health or offensive or contrary to decency; that notice be given to the District Sanitary Inspector not later than the day preceding that on which a grave is to be opened, and that no interment shall be made unless the coffin can be laid at a depth of four feet from the surface of the ground to the upper side of the coffin and that without interference with the remains of a previous interment.

## TENDERS FOR TREASURY BILLS.

1. REGULATIONS FOR THE APPOINTMENT BY COM-PETITIVE SELECTION OF DISTRICT LIVE STOCK OFFICERS (MALE) UNDER THE MINISTRY OF AGRICULTURE AND FISHERIES.

# N.B.—These Regulations are liable to alteration from time to time.

- 1. Application for appointment shall be made in the first instance to the Secretary, Ministry of Agriculture and Fisheries, at such time and in such manner as may be fixed by the Ministry. When a vacancy occurs the Ministry will cause notice to be given by advertisement in the Press, which will include a statement of the last day fixed for the receipt of applications.
- 2. A candidate must have attained the age of 25 and must not have attained the age of 45 on the last day fixed for the receipt of applications; provided that in reckoning age for this purpose a candidate who served in the Army, Navy, or Air Force between the 4th August 1914 and the 11th November 1918 may deduct from his actual age any period of service between the 4th August 1914 and the 31st December 1919.
- 3. Every candidate must be a natural-born British subject, the child of a person who is or was at the time of death a British subject; provided that exception may be made:—
  - (a) In the case of candidates serving in a civil situation to which they were admitted with the certificate of the Civil Service Commissioners.
  - (b) In the case of natural-born British subjects who served in His Majesty's Armed Forces in the Great War between 4th August 1914 and 11th November 1918.
  - (c) In the case of natural-born British subjects who have satisfactorily completed a period of not less than five years' service on full pay in His Majesty's Regular Forces.

Provided also that if the Civil Service Commissioners are satisfied, in the case of any candidate who is a British subject but does not fulfil all the requirements of the rule as to nationality and descent, that the candidate is so closely connected by ancestry and upbringing with His Majesty's dominions that an exception may properly be made to that rule,

they may accept such candidate as eligible provided that this discretion shall not be exercisable unless (a) the father or the paternal grandfather of the candidate was a natural-born British subject, and (b) neither the fathernor the paternal grandfather had acquired any other nationality by naturalization or by any other voluntary and formal act.

4. Until further notice preference will be given to candidates who served in His Majesty's Forces during the War between the 4th August 1914 and the 11th November 1918.

5. Persons holding situations in the Civil Service must obtain the permission of the authorities of their Department to apply for

appointment.

No person actually serving in the Army, Navy, or Air Force will be eligible for consideration unless he produces, when called upon to do so, the permission of his Commanding Officer to apply for appointment, dated before his appearance before the Selection Board, and given in accordance with such orders as may from time to time be issued:

Persons upon whose training for the occupation of teacher public money has been spent cannot be appointed until the consent of the appropriate education authority has been notified to the Civil Service Commissioners.

6. A candidate must satisfy the Ministry asto his practical knowledge and experience of farming and of the breeding and the management of pedigree and commercial stock (including dairy cattle). It would be an advantage for a candidate to have had practical experience

of milk-recording.

7. The completed application forms will be scrutinised by the Ministry, and selected candidates will be interviewed by a Board consisting of representatives of the Ministry and of the Civil Service Commissioners. The Board will recommend to the Ministry for appointment to the vacancies existing those candidates who appear to them to possess the highest qualifications, provided they find so many suitable.

Any attempt on the part of candidates toenlist support for their applications through Members of Parliament or other influential persons will disqualify them for appointment. The Selection Board will disregard spontaneous recommendations from persons who are not personally acquainted with the candidate's previous work.

8. The necessary number of candidates will be appointed on probation, subject to their satisfying the Civil Service Commissioners that they are eligible for appointment in respect of age, nationality, health, and character, and

to the payment of a fee of £4.

9. Service as District Live Stock Officer will be probationary for a period of two years, and the retention of an officer beyond that period will be conditional on his passing a prescribed examination after the expiry of that period.

10. A District Live Stock Officer, after passing the examination, is eligible for consideration for appointment to the established staff, if and when a vacancy occurs thereon. Appointment to the established staff is conditional on the issue by the Civil Service Commissioners of a certificate of qualification; a fee of £4, being the balance of the prescribed fee of £8, is payable before the certificate of qualification can be issued.

THE STRATHSPEY PUBLIC ASSEMBLY AND AGRICULTURAL HALLCOMPANY LIMITED.

PETITION has been presented by The Strath-A spey Public Assembly and Agricultural Hall Company Limited, incorporated under the Companies Acts, 1862 and 1867, and having its Registered Office at National Bank Buildings, Forres, to the Lords of Council and Session (Second Division,—Mr. Antonio, Clerk), craving their Lordships, inter alia, to confirm the alteration of the Memorandum of Association of the Company resolved upon by Special Resolution, passed on 1st February 1934, in the terms following:-
