- (3) Parents of children already interred
- (4) George Duncan Fyfe, foreman railway surfaceman, and Mrs. Mary Young or Fyfe, his wife, both of Cairneyhill aforesaid.

And whereas by an Order in Council of the 21st day of February 1935 Notice of such Representation was given and it was ordered that the same should be taken into consideration by a Committee of the Privy Council on the 6th day of April 1935, and that the said Order, or Notice thereof, should be published in the Edinburgh Gazette, and that copies of the said Order or Notice thereof should be fixed on the doors of the Church of, or on some other conspicuous places within the said Parish of Carnock, one month before the said 6th day of April 1935:

And whereas Notice of the said Representation and of the time when it pleased His Majesty to order the same to be taken into consideration by the Privy Council has been duly published in the Edinburgh Gazette, and fixed in manner required by the said Order in Council:

- (1) Spouses of parties already interred in the said Churchyard;
- (2) Unmarried children of parties already interred therein;
- (3) Parents of children already interred therein;
- (4) George Duncan Fyfe, foreman railway surfaceman, and Mrs. Mary Young or Fyfe, his wife, both of Cairneyhill aforesaid.

Provided always as regards future interments that the exercise of the right of burial be not injurious to public health or offensive or contrary to decency; that notice be given to the District Sanitary Inspector not later than the day preceding that on which a grave is to be opened and that no interment shall be made unless the coffin can be laid at a depth of four feet from the surface of the ground to the upper side of the coffin and that without interference with the remains of a previous interment.

DANGEROUS DRUGS ACTS, 1920 to 1932. SUSPENSION OF WITHDRAWAL OF AUTHORISATIONS.

(GEORGE SANDERS).

Whereas in pursuance of the power conferred upon the Secretary of State by Regulation 6 of the Raw Opium Regulations, 1921, as extended by the Coca Leaves and Indian Hemp Regulations, 1928, and by Regulation 7 of the Dangerous Drugs (Consolidation) Regulations, 1928, the authorisations to persons who lawfully keep open shop for the retailing of poisons in accordance with the provisions of the Pharmacy Act, 1868, as

amended by the Poisons and Pharmacy Act, 1908, to be in possession of and supply raw opium, coca leaves and Indian hemp, or to manufacture any extract or tincture of Indian hemp or any preparation to which Part III. of the Dangerous Drugs Act, 1920, applies or to carry on the business of retailing, dispensing or compounding the drugs or preparations to which Part III. of the Act applies, were, by Notice dated the 19th March 1934, and published in the London Gazette and Edinburgh Gazette on the 23rd March 1934, withdrawn from George Sanders, Pharmacist, of 157 Ombersley Road, Worcester, who had been convicted of offences against the Dangerous Drugs Acts:

Board of Trade. 8th May 1935. RULES PUBLICATION ACT, 1893. ROAD TRAFFIC ACT, 1930.

The Minister of Transport hereby gives notice under the Rules Publication Act, 1893, that he proposes after the expiry of at least forty days from this date in pursuance of the power conferred upon him by the Road Traffic Act, 1930, to make Regulations substituting for Regulation 6 of the Public Service Vehicles (Conditions of Fitness) Provisional Regulations, 1931, the following Regulation:-

"6. Where a vehicle is four wheeled the sum of the weights transmitted to the road surface by all the wheels of the vehicle shall not exceed 101 tons in the case of a doubledecked vehicle or 9 tons in the case of a single-decked vehicle; and the weight so transmitted by any two wheels of the vehicle in line transversely shall not exceed 7 tons in the case of a double-decked vehicle or 6 tons in the case of a single-decked vehicle.

Where a vehicle has more than four wheels the sum of the weights transmitted to the road surface by all the wheels of the vehicle shall not exceed 12½ tons and the weight so transmitted by any two wheels of the vehicle in line transversely shall not exceed 43 tons. In calculating the sum of the weights so transmitted when the vehicle is carrying a full complement of passengers an addition shall be made to the sum of the weights so transmitted when the vehicle is complete and fully equipped for service with a full supply of water oil and fuel at the rate of 140 lbs. each for the driver and for the conductor (if carried) and a further 140 lbs. for every passenger for which the vehicle has seating capacity."

And notice is hereby further given that on account of urgency the said Minister has, under Section 2 of the Rules Publication Act, 1893, made the Public Service Vehicles (Conditions of Fitness) (Amendment) Provisional Regulations, 1935, to come into force forthwith as Provisional Regulations and to continue in force until Statutory Rules have been made in accordance with the provisions of Section 1 of

that Act.
