The following are the Regulations to be observed in connection with the Levée to be held by the KING at St. James's Palace on Friday the 31st instant:—

## DRESS.

*Navy.* Officers, R.N., R.N.R., and R.N.V.R., in possession of Full Dress Uniform—No. 1 Dress (Full Dress).

Officers, R.N., R.N.R., and R.N.V.R., not in possession of Full Dress Uniform—No. 3 Dress (Frock Coat with Epaulettes).

*Army.* Officers in possession of Full Dress of their rank—Levée Dress.

Officers not in possession of Full Dress Uniform of their rank—Service Dress.

*Air Force.* Officers in possession of Full Dress Uniform—Full Dress.

Officers not in possession of Full Dress Uniform—Service Dress.

*Civilians.* Levée Dress.

1. Peers, Bishops, His Majesty's Lieutenants of Counties, Deputy Lieutenants of Counties, Members of Parliament, Officials connected with the Houses of Parliament, Clergy of all Denominations, and all gentlemen other than those mentioned in the following regulations, should communicate with the Comptroller, Lord Chamberlain's Office, St. James's Palace. No applications can be received from gentlemen in the foregoing categories wishing to be presented. Their names

must be forwarded by the gentlemen making the presentation.

2. A gentleman presented for the first time can only present his son on the occasion when he himself is presented.

3. All gentlemen referred to in the following Regulations, wishing to attend or be presented at a Levée, should make a written application as directed below.

4. All Officers, whether on the active or retired lists of the Royal Navy, Royal Marines, Royal Naval Reserve and Royal Naval Volunteer Reserve, will communicate with and obtain their cards, whether for attendance or presentation, from the Private Secretary to the First Lord of the Admiralty.

5. All Officers on the active, retired, and reserve lists of the Regular Army and Territorial Army, except Officers of the Household Cavalry and the Brigade of Guards, and except Officers of the Indian Services and Indian Army and Colonial Service and Colonial Forces, will communicate with and obtain their cards, whether for attendance or presentation, from the Under-Secretary of State, War Office.

All Officers on the active, retired and reserve lists of the Household Cavalry and the Brigade of Guards will communicate, through their Regimental Headquarters, with the Comptroller, Lord Chamberlain's Office, St. James's Palace, to obtain their cards for attendance or presentation.

6. All Officers on the active list of the Royal Air Force and Officers of the Special Reserve and Auxiliary Air Force will obtain their cards, for attendance or presentation, through the usual channels. Officers of the Reserve of Air Force Officers and Officers on the retired list of the Royal Air Force will communicate with and obtain their cards, whether for attendance or presentation, from the Secretary, Air Ministry, Kingsway, W.C.2.

7. All Officers of His Majesty's Civil Service will communicate with and obtain their cards for attendance or presentation from the Department under which they serve.

8. All Officers of the Indian Services and of the Indian Army, whether on the active or retired lists, will communicate with and obtain their cards, for attendance or for presentation, from the Political A.D.C. to the Secretary of State at the India Office, Whitehall.

9. All Officers of the Colonial Service and Colonial Forces, whether on active service or retired lists, will communicate with and obtain their cards, whether for attendance or presentation, from the Ceremonial and Reception Secretary, Colonial Office, Whitehall, with the exception of Officers of the local Forces of the self-governing Dominions, who will apply to the Under-Secretary of State, the War Office, for their cards for attendance or for presentation, supporting their application in all cases by a credential from the Governor-General, Governor, Officer commanding the local Forces, or the representative in London of the Dominion concerned.

10. Gentlemen connected with the Treasury, the Foreign Office, and other Government Departments will make their applications, whether for attendance or for presentation,

through the Private Secretaries to the Ministers of the respective Departments.

11. Lord Mayors and Mayors, High Sheriffs, Sheriffs, Recorders, Chairmen of Quarter Sessions, Metropolitan Police Magistrates and other Stipendiary Magistrates, and gentlemen connected with the Home Office, will make their applications, whether for attendance or for presentation, through the Ceremonial and Reception Secretary, Home Office.

12. Lord Provosts and Provosts and Conveners of County Councils will make their applications for attendance or for presentation through the Private Secretary to the Secretary of State for Scotland, at the Scottish Office, Whitehall.

Scottish Judges, Law Officers, King's Counsel and Legal Officials in Scotland should make their applications through the Legal Secretary to the Lord Advocate.

13. Chairmen of County Councils, and gentlemen connected with the Ministry of Health, will similarly make their applications through the Private Secretary to the Minister of Health.

14. Judges, Law Officers, King's Counsel, and all Legal Officials holding appointments under the Crown, other than those already mentioned, will similarly make their applications through the Private Secretary to the Lord Chancellor.

#### TENDERS FOR TREASURY BILLS.

1. The persons whose Tenders are accepted will be informed of the same not later than the following day, and payment in full of the amounts of the accepted Tenders must be made to the Bank of England by means of Cash or a Banker's Draft on the Bank of England not later than 2 o'clock (Saturday 12 o'clock) on the day on which the relative Bills are to be dated.

7. In virtue of the provisions of Section 1 (4) of the War Loan Act, 1919, Members of the House of Commons are not precluded from tendering for these Bills.

#### DANGEROUS DRUGS ACTS, 1920-1932. WITHDRAWAL OF AUTHORITY.

FRED WESTBY LOMAX.

Whereas Fred Westby Lomax, formerly of 357 Oxford Road, Manchester, being a person duly registered under the Dentists Act, 1878, as amended by the Dentists Act, 1921, and being a person duly registered under the Pharmacy Act, 1868, as amended by the Poisons and Pharmacy Act, 1908, has been convicted of offences against the Dangerous Drugs Acts:

And whereas the said Fred Westby Lomax cannot, in my opinion, properly be allowed to be in possession of or to supply raw opium, coca leaves, and Indian hemp, nor to carry on the business of manufacturing, selling, or distributing any of the drugs to which Part III. of the Dangerous Drugs Act, 1920, applies:

Now, therefore, after consultation with the Council of the Pharmaceutical Society of Great Britain, and in pursuance of the powers conferred on me by No. 6 of the Raw Opium Regulations, 1921, as extended by the Coca Leaves and Indian Hemp Regulations, 1928, and by No. 7 of the Dangerous Drugs (Consolidation) Regulations, 1928, I hereby give notice that I withdraw, as from to-day's date, from the said Fred Westby Lomax the authority granted by the said Regulations to Registered Dentists to be in possession of and to administer the drugs and preparations to which Part III. of the Dangerous Drugs Act, 1920, applies and to persons who lawfully keep open shop for the retailing of poisons to be in possession of and to supply raw opium, coca leaves, and Indian hemp, or to manufacture any extract or tincture of Indian hemp, or any preparation to which Part III. of the Dangerous Drugs Act,

1920, applies, or to carry on the business of retailing, dispensing, or compounding the drugs or preparations to which Part III. of the Act applies.

#### COAL MINES ACT, 1911.

#### ROAD TRAFFIC ACT, 1930.

##### SECTION 19 (AS AMENDED).
