ANCIENT MONUMENTS CONSOLIDA-TION AND AMENDMENT ACT, 1913.

Notice is hereby given that His Majesty in Council was pleased, on the 4th May 1935, to approve an Order in Council under the abovementioned Act, declaring that Section 14 of the said Act shall apply to the ancient monuments specified in the Order.

WHEREAS by Section 9 of the Weights and Measures Act, 1904 (4 Edw. 7, c. 28), it is provided that it shall be lawful for His Majesty by Order in Council to specify new fees to be paid in respect of the Verification and Stamping of Weights, Measures and Weighing and Measuring Instruments in substitution for the fees specified in the First Schedule of the Weights and Measures Act, 1889 (52 & 53 Vict. c. 21):

And whereas it is provided by subsection (2) of Section 3 of the Weights and Measures (Amendment) Act, 1926 (16 & 17 Geo. 5, c. 8), that the aforesaid power of His Majesty shall include and be deemed always to have included the power of specifying fees to be paid whether or not the weighing or measuring apparatus is found correct or is stamped:

And whereas His Majesty by Order in Council dated the 8th day of June 1929 (S.R. & O. 1929, No. 482) directed that the fees specified in the Schedule to that Order should be taken upon the verification and stamping of measuring instruments used in trade for the measurement of liquid fuel or lubricating oil for sale in individual quantities not exceeding twenty gallons:

twenty gallons: And whereas the Board of Trade have represented to His Majesty that it would be expedient to specify new fees to be paid upon the verification and stamping of such measuring instruments:

1. The Order in Council dated 8th June 1929 (S.R. & O. No. 482) is hereby revoked.

2. The fees specified in the Schedule hereto shall be paid in respect of the verification and stamping of measuring instruments used in trade for the measurement of liquid fuel and lubricating oil for sale in individual quantities not exceeding twenty gallons. 3. The fees specified in the Schedule hereto shall likewise be paid in respect of any such instrument which on testing is found to be incorrect or defective.

4. This Order may be cited as the Measuring Instruments (Liquid Fuel and Lubricating Oil) Verification and Stamping Fees Amendment Order, 1935, and shall come into operation on the 1st day of July 1935.

The Department of Agriculture for Scotland hereby give notice that, in exercise of their powers under the Destructive Insects and Pests Acts, 1877 to 1927, they have made the Importation of Raw Cherries (Scotland) Order of 1935, by which the landing in Scotland after the 27th May 1935 of any raw cherries grown in any European country other than Spain, France, Italy, and Germany is prohibited unless each consignment is accompanied by a certificate of origin visé by a Local Authority in the country of origin stating the country and the place where the cheeries were grown.

Cherries grown in Spain and France will be admitted without restriction until 27th May, after which date importation will be prohibited except of French cherries grown within a small district around Honfleur.

Cherries grown in Italy will be admitted until 12th June if accompanied by a certificate of origin; after that date only those grown in the region of Emilia will be allowed to enter; after 23rd June the importation of cherries grown in any part of Italy will be entirely prohibited.

Cherries grown in Germany will be admitted until 26th June if accompanied by a certificate of origin; after that date no German cherries will be admitted except those certified not to have been grown south of latitude 53° N. or in East Prussia.

The Order remains in force until 30th September 1935.
