WHEREAS the Department of Health for Scotland have, in pursuance of the powers competent to them under the Burial Grounds (Scotland) Act, 1855, made a Representation that they have received a copy of an Interlocutor, dated 18th October 1934, pronounced by the Sheriff-Substitute of Fife and Kinross at Cupar, finding that the Old Churchyard of Carnbee Parish, situated in the Village of Carnbee, Parish of Carnbee and County of Fife, is in a condition which is contrary to decency:

And whereas in the said Representation it is recommended that Burials be forthwith discontinued in the said Churchyard in terms of Section 5 of the aforesaid Act, except for the reservation of a right of burial in the said Churchyard in the cases of:-

- (1) Spouses of parties already interred in the said Churchyard;
- (2) Sons and daughters whose parents are already interred therin;
- (3) Parents of children already interred therein; and
- (4) Parties whom the County Council of the County of Fife may, upon application, specially authorise to be interred in the said Churchyard:

And whereas by an Order in Council of the 29th day of March 1935, Notice of such Representation was given and it was ordered that the same should be taken into consideration by a Committee of the Privy Council on the 10th day of May 1935, and that the said Order', or Notice thereof, should be published in the Edinburgh Gazette, and that copies of the said Order or Notice thereof should be fixed on the doors of the Church of, or on some other conspicuous places within, the Parish of Carnbee one month before the said 10th day of May 1935:

And whereas Notice of the said Representation and of the time when it pleased His Majesty to order the same to be taken into consideration by the Privy Council has been duly published in the Edinburgh Gazette, and fixed in manner required by the said Order in Council:

Now, therefore, His Majesty, by and with the advice of His Privy Council, is pleased to order, and it is hereby ordered, as follows,

That burials be forthwith discontinued, in terms of Section 5 of the Burial Grounds (Scotland) Act, 1855, in the Old Churchyard of Carnbee, situated in the Village of Carnbee, Parish of Carnbee and County of Fife, except for the reservation of a right of burial in the said Churchyard in the cases of:—

- (1) Spouses of parties already interred in the said Churchyard;
- (2) Sons and daughters whose parents are already interred therein;
- (3) Parents of children already interred therein; and
- (4) Parties whom the County Council of the County of Fife may, upon application, specially authorise to be interred in the said Churchyard:

Provided always as regards future interments that the exercise of the right of burial be not injurious to health or offensive or contrary to decency, that Notice be given to the District Sanitary Inspector not later than the day preceding that on which a grave is to be opened and that no interment shall be made unless the coffin can be laid at a depth of four feet from the surface of the ground to the upper surface of the coffin and that without interference with the remains of a previous interment.
