MILK ACT, 1934.

Notice is hereby given that the Minister of Agriculture and Fisheries and the Secretary of State for Scotland, acting jointly, have certified the cheese-milk price for the month of August 1935, as required by Sub-section 2 of Section 4 of the Milk Act, 1934, in the following terms:—

CERTIFICATION OF CHEESE-MILK PRICE.
Whereas by Sub-section (1) of Section 4 of

the Milk Act, 1934 (hereinafter referred to as "the Act"), it is provided that for the purposes of the Act the cheese-milk price for any month shall be the excess over one penny three farthings of the average of the prices per pound at which cheese such as is commonly known at the commencement of the Act as "New Zealand Finest White" and "Canadian Finest White" was sold wholesale in Great Britain during the immediately preceding month:

And whereas by Sub-section (2) of the said Section the Minister of Agriculture and Fisheries and the Secretary of State for Scotland, acting in conjunction, are required to certify as soon as may be after the beginning of September 1934, and of each subsequent month falling before April 1938, the cheese-milk price for that month;

Now therefore the Minister of Agriculture and Fisheries and the Secretary of State for Scotland, acting in conjunction, hereby certify that the cheese-milk price for the month of August 1935 is 3.79 pence per pound.

The method by which the cheese-milk price for the month as certified above has been computed is as follows:—

(i.) The range of price quotations in respect of sales by wholesale of "New Zealand Finest White" cheese and of "Canadian Finest White" cheese, as published by the London Provision Exchange, Ltd., for each of the periods ended

at 11.30 a.m. on each of the Fridays in the preceding month, has been examined.

- (ii.) The average of the mean prices for the two kinds of cheese has been ascertained for each of the said periods, exceptional quotations being disregarded. The average of the periodic averages so ascertained has then been calculated to two places of decimals and expressed in pence per pound.
- (iii.) From the figure thus obtained one penny three farthings has been subtracted and the balance gives the figure certified

The Civil Service Commissioners hereby give notice that the following Regulations are published with the approval of the Lords Commissioners of His Majesty's Treasury, viz.-

REGULATIONS RESPECTING OPEN COMPETITIVE Examinations for the Situation of Male SORTING CLERK AND TELEGRAPHIST ON THE TELEGRAPH SIDE IN BELFAST, EDINBURGH, AND CERTAIN PROVINCIAL TOWNS IN GREAT BRITAIN IN THE DEPARTMENT OF THE POST-MASTER GENERAL.

These Regulations are liable to alteration from time to time.

- 1. The limits of age for this situation are 16 and 18. Candidates must be within the prescribed limits of age on the day of the Examination.
- 2. Every candidate must be a natural-born British subject, the child of a person who is or was at the time of death a British subject. Provided that if the Civil Service Commis-

sioners are satisfied, in the case of any candidate who is a British subject but does not fulfil all the requirements of the rule as to nationality and descent, that the candidate is so closely connected by ancestry and upbringing with His Majesty's dominions that an exception may properly be made to that rule, they may accept such candidate as eligible provided that this discretion shall not be exercisable unless (a) the father or the paternal grandfather of the candidate was a naturalborn British subject, and (b) neither the father nor the paternal grandfather had acquired any other nationality by naturalisation or by any other voluntary and formal act.

- 3. Candidates will be required to satisfy the Civil Service Commissioners that they are duly qualified in respect of health and character.
- 4. At each Examination the number of candidates to be selected will be such as the Postmaster-General may from time to time fix.
- 5. The Examination will be in the following subjects, viz.:—

- English.
 Handwriting.
- 3. History.
- 4. Geography.
- 5. Arithmetic.

Candidates must satisfy the Civil Service Commissioners in Handwriting and in the Examination as a whole.

- 6. The Examination is open only to local candidates. A local candidate is regarded as one whose family home (i.e. with parents or guardians) is situated where he can travel to and from the office conveniently and without detriment to his health or the interests of the Department. No candidate will be eligible for appointment unless he can satisfy the Postmaster-General that he possesses the required local residential qualification and it will be within the Postmaster-General's authority to decline to employ a candidate successful in the examination if he is not satisfied that he complies with this requirement. If there is any doubt an intending candidate is advised to enquire of the Head Postmaster of the town at which the situation is vacant (not the Civil Service Commissioners) whether, in the event of his success in the Examination he would be regarded as eligible for appointment in respect of residence.
- 7. Candidates must be at least 5 feet in height, and no officer will be retained in the Service who does not attain the height of 5 feet 4 inches before completing his nineteenth
- 8. (i.) Persons actually serving in the Army, Navy, or Air Force are ineligible to compete. (ii.) Persons holding situations in the Civil Service, Probationary Engineer Cadets in the Navy, and Apprentices in His Majesty's Dockyards must obtain the permission of the authorities of their Department to attend the Examination before the commencement of the competition.
- 9. Persons upon whose training for the occupation of teacher public money has been spent cannot be appointed until the consent of the appropriate education authority has been notified to the Civil Service Commissioners.
- 10. Application for permission to attend an Examination must be made at such time and in such manner as may be fixed by the Civil Service Commissioners.
- 11. A fee of 10s. will be required from every Candidate attending an Examination.
