SUSPENSION OF WITHDRAWAL OF AUTHORISATIONS.

(FRANK ARTHUR EVISON.)

applies; and has also suspended the direction, given at the same time, that it should not be lawful for Dr. Evison to give prescriptions for the purposes of the aforesaid Regulations.

- 1. The number of County Councillors for the County shall be increased from 81 to 82.
- 2. The number of County Councillors to be elected by the Town Council of Fort William shall be increased from two to three.
