The persons whose Tenders are accepted will be informed of the same not later than the following day, and payment in full of the amounts of the accepted Tenders must be made to the Bank of England by means of Cash or a Banker's Draft on the Bank of England not later than 2 o'clock (Saturday 12 o'clock) on the day on which the relative Bills are to be dated.

THE PHARMACY AND POISONS ACT, 1933.

The Secretary of State for the Home Department gives notice that, in pursuance of the provisions of the Pharmacy and Poisons Act, 1933, he has made Orders, dated 21st December 1935,

(i.) confirming, with certain modifications, the list, prepared by the Poisons Board, of the substances to which the Act applies;

(ii.) approving certain hospitals and other institutions for the purposes of Section 20 (4) of the Act.

The Secretary of State has also, in pursuance of his powers under the Act, made Rules with respect to the sale, supply, transport, and storage of poisons and other matters specified in Section 23 of the Act. The Rules do not come into force until May 1st, 1936, the date upon which the main provisions of the Pharmacy and Poisons Act, 1933, relating to the sale of poisons will come into operation by virtue of an Order in Council dated June 6th, 1935 (S.R. & O, 1935/520).

RULES PUBLICATION ACT, 1933. ROAD TRAFFIC ACT, 1930.

(c) No passenger shall leave or attempt to leave the vehicle without paying the fare for the journey which he has taken, and with intent to avoid payment
