The Civil Service Commissioners hereby give notice that the following Regulations are published with the approval of the Lords Commissioners of His Majesty's Treasury, viz.:—

**REGULATIONS FOR THE COMPETITIVE SELECTION  
OF INSPECTORS OF FACTORIES IN THE HOME  
OFFICE.**

*N.B.—Competitions under these regulations are open both to men and women. Competitions do not take place at fixed intervals, but are held as occasion arises on the occurrence of vacancies. The regulations are liable to alteration from time to time.*

1. Candidates must have attained the age of 23 and must not have attained the age of 30 on a date to be fixed in respect of the competition in which they are to take part. In the case, however, of candidates having exceptionally suitable qualifications (see Clause 6 of the regulations) consideration may be given to applications from older candidates if they are under the age of 34.

2. Every candidate must be a natural-born British subject, the child of a person who is or was at the time of death a British subject; provided that exception may be made:—

(a) In the case of candidates serving in a civil situation to which they were admitted with the certificate of the Civil Service Commissioners.

(b) In the case of natural-born British subjects who served in His Majesty's Armed Forces in the Great War between 4th August 1914 and 11th November 1918.

(c) In the case of natural-born British subjects who have satisfactorily completed a period of not less than five years' service on full pay in His Majesty's Regular Forces.

Provided also that if the Civil Service Commissioners are satisfied, in the case of any candidate who is a British subject but does not fulfil all the requirements of the rule as to nationality and descent, that the candidate

is so closely connected by ancestry and upbringing with His Majesty's dominions that an exception may properly be made to that rule, they may accept such candidate as eligible provided that this discretion shall not be exercisable unless (a) the father or the paternal grandfather of the candidate was a natural-born British subject, and (b) neither the father nor the paternal grandfather had acquired any other nationality by naturalization or by any other voluntary and formal act.

3. Persons holding situations in the Civil Service must obtain the permission of the authorities of their Department to apply for appointment.

No person actually serving in the Army, Navy, or Air Force, will be eligible for consideration unless he produces, when called upon to do so, the permission of his Commanding Officer to apply for appointment, dated before his appearance before the Selection Board, and given in accordance with such orders as may from time to time be issued.

Persons upon whose training for the occupation of teacher public money has been spent cannot be appointed until the consent of the appropriate education authority has been notified to the Civil Service Commissioners.

4. The Home Office will take such steps as they think most appropriate to make known the existence of any vacancy or vacancies which they desire to fill on any one occasion, and the Civil Service Commissioners will satisfy themselves that the steps taken have been such as to secure all desirable publicity.

5. Applications shall be addressed in the first instance to the Home Office, and shall be made on a form to be obtained from that Office, which must be stamped by the applicant with a "Civil Service" stamp or stamps of the value of five shillings; this fee is payable in respect of the application and will not be returned in any circumstances. A fresh application must be made in connection with each competition; applications submitted in connection with previous competitions cannot be accepted. The Home Office will examine the candidates' credentials and will submit the names of such candidates as appear to be best qualified to the Civil Service Commissioners, who, if dissatisfied with the number or quality of candidates for any vacancy, may require further search to be made for suitable candidates. The Civil Service Commissioners may, if they think fit, assist in the scrutiny of the application forms of the candidates.

6. Candidates must satisfy the Civil Service Commissioners that they have such experience and have received such systematic education, general or technical, or general and technical together, as in the opinion of the Commissioners fits them for the post. In general, candidates should either have passed an examination qualifying for a university degree, or should possess an equivalent qualification in engineering, industry, or science; but the Commissioners may dispense with this requirement in the case of a candidate who appears to them to be exceptionally well fitted by reason of suitable works or other special practical experience. Candidates summoned before the Selection Board will be required to pass an examination in English.

7. Candidates who are recommended by the

Home Office and who are accepted by the Civil Service Commissioners as possessing the requisite qualifications will be summoned to an interview before a Selection Board, who will select for the vacancies existing those candidates who appear to them to possess the highest qualifications and their decision will be final. The Selection Board will be nominated by the Commissioners in consultation with the Home Office who will be represented on the Selection Board, and, when practicable, one of the Commissioners will be the Chairman. The Selection Board will take into consideration the candidate's record of experience and education, any recommendations that they may receive from persons named by candidates as having direct knowledge of their work in the past, and the personal qualities of the candidates as shown at this interview; and on their estimation of all the above evidence they will frame their decisions.

8. Any attempt on the part of candidates to enlist support for their applications through Members of Parliament or other influential persons will disqualify them for appointment. The Selection Board will disregard spontaneous recommendations from persons who are not personally acquainted with the candidate's work, whether at school, at the university, in industry or business, in the Forces, or otherwise.

9. Candidates chosen by the Selection Board must satisfy the Civil Service Commissioners as to their health and character.

Women candidates must be unmarried or widows and will be required to resign their appointments on marriage.

10. In the allocation of candidates to vacancies the Civil Service Commissioners will have due regard to the requirements of the situation or situations to be filled.

11. In addition to the fee of five shillings payable on application (Clause 5), each candidate admitted to the written examination (Clause 6) will be required to pay a fee of £1. A selected candidate will be required to pay a fee of £4 5s. Od., towards which the fees paid on application and on examination will count, before the issue of the certificate of qualification for appointment.

#### MILK ACTS, 1934 AND 1936.

Notice is hereby given that the Minister of Agriculture and Fisheries and the Secretary of State for Scotland, acting jointly, have certified the cheese-milk price for the month of December 1936, as required by Sub-section 2 of Section 4 of the Milk Act, 1934, as amended by Section 5 and Part II. of the Schedule of the Milk (Extension of Temporary Provisions) Act, 1936, in the following terms:—

#### CERTIFICATION OF CHEESE-MILK PRICE.

Whereas by Sub-section (1) of Section 4 of the Milk Act, 1934 (hereinafter referred to as "the Act"), it is provided that for the purposes of the Act the cheese-milk price for any month shall be the excess over one penny three farthings of the average of the prices per pound at which cheese such as is commonly known at the commencement of the Act as "New Zealand Finest White" and "Canadian Finest White" was sold wholesale in Great Britain during the immediately preceding month;

And whereas by Sub-section (2) of the said Section as amended by Section 5 and Part II. of the Schedule of the Milk (Extension of Temporary Provisions) Act, 1936, the Minister of Agriculture and Fisheries and the Secretary of State for Scotland, acting in conjunction, are required to certify as soon as may be after the beginning of September 1934, and of each subsequent month falling before October 1939, the cheese-milk price for that month;

Now therefore the Minister of Agriculture and Fisheries and the Secretary of State for Scotland, acting in conjunction, hereby certify that the cheese-milk price for the month of December 1936 is 5'98 pence per pound.

The method by which the cheese-milk price for the month as certified above has been computed is as follows:—

(i.) The range of price quotations in respect of sales by wholesale of "New Zealand Finest White" cheese and of "Canadian Finest White" cheese, as published by the London Provision Exchange, Ltd., for each of the periods ended at 11.30 a.m. on each of the Fridays in the preceding month, has been examined.

(ii.) The average of the mean prices for the two kinds of cheese has been ascertained for each of the said periods, exceptional quotations being disregarded. The average of the periodic averages so ascertained has then been calculated to two places of decimals and expressed in pence per pound.

(iii.) From the figure thus obtained one penny three farthings has been subtracted and the balance gives the figure certified above.
