### ROAD TRAFFIC ACT, 1930.

### ROAD AND RAIL TRAFFIC ACT, 1933.

In the case of heavy locomotives, light locomotives, motor tractors, and motor vehicles constructed to carry goods other than the effects of passengers and authorised to be used under C licences paragraph (ii.) of sub-section (1) of Section 19 of the Act shall be varied so as to provide that on not more than two days in each of the three weeks ending on the 19th day of December 1936, the 26th day of December 1936, and the 2nd day of January 1937 respectively, the limit of 12 hours may be substituted for the limit of 11 hours imposed by the said paragraph in respect of the aggregate of continuous periods of driving.
