YESTERDAY morning, at twenty minutes after eleven o'clock, Her Royal Highness The Duchess of Kent was safely delivered of a daughter at 3 Belgrave Square.

His Royal Highness The Duke of Kent and Her Royal and Imperial Highness Princess Nicholas of Greece were present.

Secretary Sir John Simon was also present.

Her Royal Highness and the Infant Princess are doing excellently.

The happy event was made known by the firing of the Park and Tower guns.

CEREMONIAL observed at proclaiming HIS MAJESTY KING GEORGE THE SIXTH at the Mercat Cross of Edinburgh, the 14th day of December 1936.

THIS day, in consequence of an Order in Council of the 12th day of December, His Majesty King George VI. was proclaimed between the hours of twelve noon and two afternoon, first at the Mercat Cross, then at the Gate of the Castle, then in front of His Majesty's Royal Palace of Holyroodhouse, and lastly at the Pier and Shore of Leith, with the usual solemnities.

The Lord Provost, Magistrates, and Council of the City of Edinburgh, along with the persons and public bodies after mentioned, assembled at the Parliament House at Half-past Eleven o'clock A.M., for the purpose of assisting at the ceremony of Proclaiming His Majesty the King. The Judges, Magistrates, and other official persons appeared in their robes or uniforms.

The Procession was marshalled in the following order by Albany Herald and Unicorn Pursuivant, and moved from the Parliament House at 11.45 a.m.

The Procession left the Parliament House at 11.50 A.M. and proceeded to the Mercat Cross. The King's Bodyguard for Scotland (Royal Company of Archers), under command of Brigadier John A. Inglis, and the Guard of Honour, consisting of three officers and 50 rank and file of the 1st Battalion of the Gordon Highlanders, were drawn up on each side of the Cross. The other persons and public bodies attending the Proclamation, with the exception of those after mentioned, were drawn up in the open space to the north of the Cross. On reaching the Cross, the Lord Provost, accompanied by the Town Clerk, the Chief City Officer, sword, mace, and halbert bearers, proceeded to the balcony of the Cross, and after a fanfare of trumpets, read the Proclamation to the inhabitants of the City of Edinburgh. At the close of the Proclamation by the Lord Provost, the State Trumpeters, Pursuivants, Heralds, Lord Lyon King of Arms, and Sheriff, having now ascended the Cross, the Proclamation was, after a fanfare of trumpets, made to the people of the Kingdom of Scotland, and at request of the Sheriff to the lieges of the Sheriffdom of the Lothians and Peebles, by Lord Lyon King of Arms, who thereafter did proclaim the style and titles of His Majesty, with a flourish of trumpets from the State Trumpeters, a Royal Salute from the Royal Company of Archers, and from the Guard of Honour, and another Royal Salute of twenty-one guns from the guns of the Castle. Thereafter the Lord Lyon King of Arms called for three cheers for His Majesty, which were enthusiastically given by the vast assemblage of spectators.

The Procession, consisting of the State Trumpeters and Officers of Arms, the Lord Provost, Magistrates, and Council of the City and Officers of the Headquarters Staff of the Scottish Command, and others then proceeded to the Gate of the Castle, where they were received by a Guard of Honour, furnished by the 7/9th Royal Scots. The Proclamation was read by Falkland Pursuivant with the usual solemnities.

The Procession having now re-formed, returned down the Castle Hill and High Street, the Officers of the Headquarters Staff having now fallen out, and proceeded by way of the Canongate to the Royal Palace of Holyroodhouse, where they were received by the Guard of Honour furnished by the 1st Battalion of the Gordon Highlanders. Proclamation was then made in front of the chief doorway by Albany Herald with solemnities as before.

Thereafter the State Trumpeters, Officers of Arms, Magistrates, and Lord Provost proceeded to the Pier and Shore of Leith, where the Proclamation was made by Unicorn Pursuivant with the same solemnities. The Guard of Honour was furnished by the 7/9th Battalion Royal Scots.

After the last day for application has been reached, the authorities of the Department will scrutinise all the applications received and recommend to the Commissioners such candidates as appear to them to be best qualified for the They will at the same time forward duties. to the Civil Service Commissioners the application forms of the candidates recommended, together with the forms of any candidates not recommended who are employed in a Government Department; and the list of candidates to be interviewed by the Selection Board will then be settled by agreement between the Department and the Civil Service Commissioners, who may, if dissatisfied with the candidates recommended, take such steps in consultation with the Department as they think fit to obtain other candidaes.

3. Candidates recommended by the Department and accepted by the Civil Service Commissioners as possessing the requisite qualifications will be summoned to an interview before a Selection Board, who will select for the vacancies existing those candidates who appear to them to possess the qualifications most suited to the posts to be filled. The Selection Board will usually comprise representatives of the Civil Service Commission, the Department, and a nominee of the Surveyors' Institution.

Other things being equal, preference will be given to candidates who served in His Majesty's Forces between 4th August 1914 and 11th November 1918.

4. Candidates must have attained the age of 25 and ordinarily should not have attained the age of 35 on a date to be fixed in respect of the competition in which they are to take part. 5. Women candidates must be unmarried or widows and will normally be required to resign their appointments on marriage; but exception to the rule requiring resignation on marriage may, in individual circumstances, be made where the employment of a married woman is considered advisable in the light of her special qualifications, or special experience in relation to the duties required of her, or of the special requirements of the Department.
