The following are the Regulations to be observed in connection with the Levée to be held by The KING at St. James's Palace on Friday the 28th instant, at 11.30 a.m.

#### DRESS.

Navy. Officers, R.N., R.N.R., and R.N.V.R.
—No. 1 Dress (Full Dress).

Officers not in possession of Full Dress Uniform, and who are not required by the Regulations to provide it—No. 3 Dress (Frock Coat with Epaulettes).

Army. Officers in possession of Full Dress of their rank—Levée Dress.

Officers not in possession of Full Dress Uniform of their rank—Service Dress.

Air Force. Officers in possession of Full Dress Uniform—Full Dress.

Officers not in possession of Full Dress Uniform—Service Dress.

Civilians. Levée Dress.

1. Peers, Bishops, His Majesty's Lieutenants of Counties, Deputy Lieutenants of Counties, Members of Parliament, Officials connected with the Houses of Parliament, Clergy of all Denominations, and all gentlemen other than those mentioned in the following Regulations, should communicate with the Comptroller, Lord Chamberlain's Office, St. James's Palace. No applications can be received from gentlemen in the foregoing categories wishing to be presented. Their names must be forwarded by the gentleman making the presentation.

2. A gentleman presented for the first time may present only his son on the occasion when

he himself is presented.

3. All gentlemen referred to in the following Regulations, wishing to attend or be presented at a Levée, should make a written application as directed below.

4. All Officers, whether on the active or retired lists of the Royal Navy, Royal Marines, Royal Naval Reserve, and Royal Naval Volunteer Reserve, will communicate with and obtain their cards from the Private Secretary to the First Lord of the Admiralty.

5. All officers on the active, retired, and reserve lists of the Regular Army and Terri-

torial Army, except Officers of the Household Cavalry and the Brigade of Guards, and except Officers of the Indian Services and Indian Army and Colonial Service and Colonial Forces, will communicate with and obtain their cards from the Under-Secretary of State, War Office.

All Officers on the active, retired, and reserve lists of the Household Cavalry and the Brigade of Guards will communicate, through their Regimental Headquarters, with the Comptroller, Lord Chamberlain's Office, St. James's Palace, to obtain their cards for presentation.

- 6. All Officers on the active list of the Royal Air Force and Officers of the Special Reserve and Auxiliary Air Force will obtain their cards through the usual channels. Officers of the Reserve of Air Force Officers and Officers on the retired list of the Royal Air Force will communicate with and obtain their cards from the Secretary, Air Ministry, Kingsway, W.C.2.

  7. All Officers of His Majesty's Civil Service
- 7. All Officers of His Majesty's Civil Service will communicate with and obtain their cards from the Department under which they serve.
- 8. All Officers of the Indian Services and of the Indian Army, whether on the active or retired lists, will communicate with and obtain their cards from the Political A.D.C. to the Secretary of State at the India Office, Whitehall.
- 9. All Officers of the Colonial Service and Colonial Forces, whether on the active or retired lists, will communicate with and obtain their cards from the Ceremonial and Reception Secretary, Colonial Office, Whitehall, with the exception of Officers of the local Forces of the self-governing Dominions, who will apply to the Under-Secretary of State, the War Office, for their cards, supporting their application in all cases by a credential from the Governor-General, Governor, Officer commanding the local Forces, or the representative in London of the Dominion concerned.

10. Gentlemen connected with the Treasury, the Foreign Office, and other Government Departments will make their applications through the Private Secretaries to the Ministers of the respective Departments.

il. Lord Mayors and Mayors, High Sheriffs, Sheriffs, Recorders, Chairmen of Quarter Sessions, Metropolitan Police Magistrates and other Stipendiary Magistrates, and gentlemen connected with the Home Office, will make their applications through the Ceremonial and Reception Secretary, Home Office.

12. Lord Provosts and Provosts and Conveners of County Councils will make their applications through the Private Secretary to the Secretary of State for Scotland, at the Scottish Office, Whitehall.

Scottish Judges, Law Officers, King's Counsel and Legal Officials in Scotland should make their applications through the Legal Secretary to the Lord Advocate.

- 13. Chairmen of County Councils, and gentlemen connected with the Ministry of Health, will similarly make their applications through the Private Secretary to the Minister of Health.
- 14. Judges, Law Officers, King's Counsel, and all Legal Officials holding appointments under the Crown, other than those already mentioned, will similarly make their applications through the Private Secretary to the Lord Chancellor.

15. The names must be received at the various Offices above indicated as soon as possible, and in any case not later than twelve days prior to the date of the Levée.

#### TENDERS FOR TREASURY BILLS.

- The persons whose Tenders are accepted will be informed of the same not later than the

following day, and payment in full of the amounts of the accepted Tenders must be made to the Bank of England by means of Cash or a Banker's Draft on the Bank of England not later than 2 o'clock (Saturday 12 o'clock) on the day on which the relative Bills are to be dated.

#### MILK ACTS, 1934 AND 1936.

Notice is hereby given that the Minister of Agriculture and Fisheries and the Secretary of State for Scotland, acting jointly, have certified the cheese-milk price for the month of May 1937, as required by Sub-section 2 of Section 4 of the Milk Act, 1934, as amended by Section 5 and Part II. of the Schedule of the Milk (Extension of Temporary Provisions) Act, 1936, in the following terms:—

#### CERTIFICATION OF CHEESE-MILK PRICE.

Whereas by Sub-section (1) of Section 4 of the Milk Act, 1934 (hereinafter referred to as "the Act"), it is provided that for the purposes of the Act the cheese-milk price for any month shall be the excess over one penny three farthings of the average of the prices per pound at which cheese such as is commonly known at the commencement of the Act as "New Zealand Finest White" and "Canadian Finest White" was sold wholesale in Great Britain during the immediately preceding month;

And whereas by Sub-section (2) of the said Section as amended by Section 5 and Part II. of the Schedule of the Milk (Extension of Temporary Provisions) Act, 1936, the Minister of Agriculture and Fisheries and the Secretary of State for Scotland, acting in conjunction, are required to certify as soon as may be after the beginning of September 1934, and of each subsequent month falling before October 1939, the cheese-milk price for that month;

Now therefore the Minister of Agriculture and Fisheries and the Secretary of State for Scotland, acting in conjunction, hereby certify that the cheese-milk price for the month of May 1937 is 5.92 pence per pound.

The method by which the cheese-milk price for the month as certified above has been computed is as follows:—

(i.) The price quotations in respect of sales by wholesale of "New Zealand Finest White" cheese and of "Canadian Finest White" cheese published in the Official Market Report of the London Provision Exchange, Ltd., for each of the weekly periods ended at 11.30 a.m. on each of the Fridays in the preceding month have been examined.

(ii.) For each of the said periods and for each description of "Canadian Finest White" cheese quoted in the Official Market Report a mean price has been calculated by taking the mean value of the highest and

lowest prices quoted, quotations described in the Report as being exceptional being disregarded.

(iii.) An average price for "Canadian Finest White" cheese for each of the said periods has been calculated by taking the average of the aforesaid mean prices.

average of the aforesaid mean prices.

(iv.) An average price for "New Zealand Finest White" cheese for each of the said periods has been ascertained in a similar fashion.

(v.) A mean of the average prices for "Canadian Finest White" cheese and "New Zealand Finest White" cheese so ascertained has been calculated for each of the said periods. The average of such mean prices so ascertained has then been expressed in pence per pound, calculated to two places of decimals.

(vi.) From the figure thus obtained one penny three farthings has been subtracted and the balance gives the figure certified
