NATIONAL HEALTH INSURANCE ACT, 1936.

except in certain cases where the persons are engaged under the conditions mentioned in the Fifth Schedule to the Order;

(b) certain blind outworkers;

(c) outworkers who are not themselves substantially engaged on the actual manipulation of the articles or materials given out; and

(d) certain classes specified in the Third Schedule to the Order employed under any local or other public authority

shall be excluded from the scope of compulsory insurance; and providing further that certain married women outworkers and pack shepherds shall be deemed to be employed within the meaning of the Act.

The only change which the proposed Order will make on the existing Order is that the outworkers described in paragraph (c) will be excluded from the scope of compulsory insurance if, and when, the Order is made.
