ORDER by the Secretary of State under Section 62 (5) of the Glasgow Boundaries Act, 1925, as read with Section 3 (1) of the Lanarkshire, Renfrewshire and Dunbartonshire Education Authorities Order, 1929.

WHEREAS by the Glasgow Boundaries Act, 1925 (hereinafter referred to as "the Act of 1925"), the boundaries of the City and Royal Burgh of Glasgow (hereinafter referred to as "the City") were extended by the inclusion therein of, inter alia, part of the area of the county of Lanark (hereinafter referred to as "the transferred area");

And whereas it is provided by Section 62 (5) of the Act of 1925 that the Secretary of State shall, after such enquiry, if any, as he thinks necessary, make provision by Order for, inter alia, the transfer to the education authority for the city of the debts, liabilities, properties and

assets or part thereof of the existing education authority for the county of Lanark and for the adjustment of all claims and disputes arising out of the transfer and all questions, claims and matters arising out of or in consequence of the carrying into effect of the provisions of this section;

And whereas it is provided by Section 3 of the Lanarkshire, Renfrewshire and Dunbartonshire Education Authorities Order, 1929, that

- (1) Section 62 of the Act of 1925 shall be read and have effect as though among the matters which the Secretary of State is thereby directed to make provision for by Order there were included financial adjustments as between, inter alios, the Education Authority for the County of Lanark and the Glasgow Education Authority consequent upon the alteration of boundaries effected by the Act of 1925 and as though the said financial adjustments were directed to be made upon the basis of the provisions of the Local Government (Adjustments) (Scotland) Act, 1914, and in accordance with the rules contained in the Schedule to that Act, and
- (2) In determining the sum, if any, to be paid by the Glasgow Education Authority in respect of the said financial adjustments the cost of the said Order of 1929 shall be taken into consideration;

And whereas by virtue of the Local Government (Scotland) Act, 1929, the functions, property and liabilities of the education authorities of the city, and of the county of Lanark, were transferred to the Town Council of the city (hereinafter referred to as "the Corporation") and to the County Council of Lanark (hereinafter referred to as "the County Council") respectively.

Now therefore I, the Right Honourable Walter E. Elliot, one of His Majesty's Principal Secretaries of State, do hereby make the following Order:—

- (1) There shall be transferred to the Corporation, notwithstanding the date of this Order, all such property and assets within the transferred area as at 15th May 1926 belonged to or were vested in or held in trust for the Education Authority of the County of Lanark, subject to all debts and liabilities affecting the same in so far as not otherwise provided for in this Order;
- (2) The Corporation shall pay to the County Council:—
  - (a) The sum of £1227 2s. 6d., being the amount of the feuduties, with interest thereon, paid by the Education Authority of the County of Lanark and the County Council since the 15th May 1926 in respect of the properties transferred under this Order;
  - (b) The sum of £403 11s. 5d., being a proportion of the cost of obtaining the Lanarkshire, Renfrewshire and Dunbartonshire Education Authorities Order, 1929:
  - (c) The sum of £34,596 8s. 7d. in respect of the increase of burden thrown on the ratepayers of the County of Lanark by virtue of the provisions of the Act of 1925.

(3) This Order may be cited as the Glasgow Corporation (Transfer of Debts, &c.) Order, 1937.

THE DISTRICT OF THE RIVER BRORA (ANNUAL CLOSE TIME) ORDER, 1937.

In pursuance of the powers vested in me, and upon application by Petition from the District Board of the River Brora, in terms of section 9 of the Salmon Fisheries (Scotland) Act, 1868 (a), I, the Right Honourable Walter Elliot Elliot, one of His Majesty's Principal Secretaries of State, do hereby make the following Order:—

1. The Annual Close Time for the District of the River Brora shall commence on the 27th day of August in each year and terminate on the 10th day of February next ensuing, both days inclusive.

2. It shall be lawful to fish for and to take salmon with the rod and line in the District of the River Brora from the 1st day of February to the 10th day of February, both days inclusive, and from the 27th day of August to the 15th day of October, both days inclusive, in each year.

3. This Order shall take effect forthwith, and may be cited as the District of the River Brora (Annual Close Time) Order, 1937.
