He showed great resource and extraordinary courage of a very high order in moving about outside the cockpit during the flight, carrying oil by means of a thermos cover from one engine to another, while clinging to the struts. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.
- 5. Tenders must be made through a London Banker, Discount House, or Broker.
- 6. The persons whose Tenders are accepted will be informed of the same not later than the following day, and payment in full of the amounts of the accepted Tenders must be made to the Bank of England by means of Cash or a Banker's Draft on the Bank of England not later than 2 o'clock (Saturday 12 o'clock) on the day on which the relative Bills are to be dated.

KIRKINTILLOCH GAS.

(Application for Special Order under the Gas Undertakings Acts 1920 to 1934.)

NOTICE is hereby given that application is intended to be made to the Board of Trade forthwith by the Provost Magistrates and Councillors of the Burgh of Kirkintilloch (hereinafter referred to as "the Town Council") whose address is Council Chambers Kirkintilloch for a Special Order under the Gas Undertakings Acts 1920 to 1934 for all or some of the following (amongst other) purposes (that is to say):—

To extend the existing limits of gas supply of the Town Council and to authorise them to supply gas within that part of the Parish of Campsie in the County of Stirling within which the Town Council are not presently supplying gas (hereinafter referred to as "the added limits").

To transfer to and vest in the Town Council the undertaking of the Lennoxtown Gas Light Company (constituted by Contract of Copartnery and hereinafter referred to as "the Lennoxtown Company") including certain lands forming part of that undertaking and the gasworks of the Lennoxtown Company situate thereon and all property and assets powers rights and privileges of the Lennoxtown Company upon and subject to such terms and conditions and subject to such provisions with regard to the liabilities and obligations of the Lennoxtown Company as have been agreed between the Town Council and the Lennoxtown Company or as may be prescribed by the Order and to prescribe the date on which such transfer and vesting shall take effect.

To sanction and confirm or give effect to any agreement made or to be made between the Town Council and the Lennoxtown Company with reference to the transfer and vesting of the

undertaking of the Lennoxtown Company to and in the Town Council.

To make provision as to contracts and debts existing at the date of transfer and all such other provisions as may be necessary or expedient for enabling the said transfer and vesting to be carried into effect.

To empower the Town Council to erect maintain alter improve and renew gasworks with all necessary machinery and apparatus and to make and store gas and to work up and convert residual products upon the lands hereinafter described and to purchase and use material required to work up and convert residual products.

The said lands are -

Two pieces of ground situate in the Parish of Campsie and County of Stirling belonging to the Lennoxtown Company being the site of the existing gasworks of the said Company consisting of (1) all and whole that area of ground containing one rood six and one half poles Imperial Measure or thereby and bounded as follows, viz.: -On the West by ground belonging or reputed to belong to James and John Downie, Weavers; on the North by ground belonging or reputed to belong to the Trustees of the late Captain William MacFarlane of Bencloich; on the South by ground belonging or reputed to belong to Robert Downie; and on the East by a road leading from the Kilsyth and Campsie Road to the Coal and Lime Works, at or near Neuck; and (2) all and whole that area of ground, part of the Estate of Bencloich containing one rood four and one third poles Imperial Measure or thereby and bounded as follows, viz.:—On the North and East by the lands of Bencloich; on the South partly by the Bencloich Road leading past the Lennoxtown Free Church and partly by the North Bank of the Bencloich burn; and on the West by the lands of Woodhead Estate.

To provide that, subject to the provisions of the Order, the Town Council shall have and may exercise within the added limits or any part or parts thereof all powers, rights, privileges and authorities which they have within their existing limits of gas supply.

To authorise the Town Council to charge differential prices within their existing limits of gas supply and within the added limits or any part or parts thereof.

Powers and provisions as to:—Supply and purchase of gas in bulk; breaking up streets on boundary of limits of supply; laying of pipes in private streets; service pipes in common stairs &c.; supply of gas fittings &c.; construction and placing of pipes and fittings; position of meters; charges for special reading of meters; notice to Town Council before mains are interfered with; tenants to be liable for sub-tenants gas charges in certain cases; relief from obligation to supply gas in certain cases; expense of re-connecting discontinued supplies; notices to Town Council from consumers; provision of showrooms offices exhibitions and demonstrations in connection with gas undertaking; dwelling-houses and other buildings in connection with gas undertaking; authentication and service of notices and other powers usually conferred on gas undertakers.

Power to provide reserve fund.

Imposition recovery and application of penalties and other sums due to the Town Council.

The Order will vary or extinguish all rights and privileges which would impede or interfere with its purposes and confer other rights and privileges.

To incorporate with the Order with or without modification all or some of the provisions of the Lands Clauses Acts, the Gasworks Clauses Act 1847 and the Gasworks Clauses Act 1871 and to repeal alter extend or amend or to make applicable to the objects and purposes of the Order the provisions or some of the provisions of the Burghs Gas Supply (Scotland) Acts 1876 to 1918 and any other Act or Order relating to the Town Council or their gas undertaking.

Any local or other public authority company or person desiring to bring before the Board of Trade any objection to the Draft Order may do so by registered letter addressed to the Director of Gas Administration, Board of Trade, Great George Street, London, S.W.1, and despatched on or before the fifteenth day of September 1937. Any such objection shall state—

- (a) The specific grounds of objection and
- (b) The omissions, additions or modifications asked for.
