PROPOSAL TO VARY MINIMUM RATES OF WAGES.

In accordance with Regulations made by the Minister of Labour under section 18 of the Trade Boards Act, 1909, and dated 21st April 1927, the Paper Bag Trade Board (Great Britain) hereby give notice that they propose to yary minimum rates of wages at present set out in their Notice P. (17), dated 28th February 1930, so as to provide for the current rates of

wages being paid for a week of 45 hours instead of 48 hours.

MERCHANDISE MARKS ACT, 1926.

REFERENCE TO THE STANDING COMMITTEE.

In accordance with the provisions of subsection (4) of Section 2 of the Merchandise Marks Act, 1926, the Board of Trade give notice that, in pursuance of an application received by them for the making of an Order in Council to require imported goods of certain classes and descriptions to bear an indication of origin, they have made a reference to the Standing Committee appointed by them under the Act in respect of the following descriptions of imported goods:—

Basketware of the following descriptions made wholly or mainly of cane, wicker, bamboo, rush, straw, raffia, or seagrass, or of fabrics woven from paper, jute, or hemp yarn:—

- (1) Baskets (other than fruit bushels, cucumber and game flats and similar baskets ordinarily used for the transport of food).
  - (2) Furniture and frames therefor.

Attention is called to the fact that while, under the provisions of the above Act, the Committee must in every case referred to them consider whether the goods should bear an indication of origin at the time of sale or exposure for sale, they may also at their discretion consider and report upon the question whether such goods should bear an indication of origin at the time of importation.
