The KING's Most Excellent Majesty in Council.

WHEREAS there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 19th day of November 1937 (N. 7224/37), in the words following, viz:—

“Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted, *inter alia*, that all pay, pensions, or other allowances in the nature thereof payable in respect of services in Your Majesty's Naval or Marine Force to a person being or having been an Officer, Seaman, or Marine therein shall be paid in such manner and subject to such restrictions, conditions, and provisions as are from time to time directed by Order in Council:

“And whereas under Orders in Council of 9th October 1919, 11th October 1921, 30th July 1923, 15th June 1928, and 23rd July 1931, a higher fire control allowance of 3d. a day is payable to a limited number of ratings of the Regulating, Writer, Supply, Officers' Steward, Officers' Cook and Cook Branches and Band ranks, R.M., who are engaged on the more important duties in the fire control system in certain classes of Your Majesty's ships:

“And whereas in view of the developments and complexity of the fire control system it is desired to extend payment of the allowance, under the conditions hitherto in force, to all classes of ships, the number of allowances in

each vessel to be regulated by Service requirements at our discretion:

“We beg leave humbly to recommend that Your Majesty may be graciously pleased, by Your Order in Council, to sanction the extension of payment accordingly.

“The Lords Commissioners of Your Majesty's Treasury have signified their concurrence in this proposal.”

His Majesty, having taken the said Memorial into consideration, was pleased, by and with the advice of His Privy Council, to approve of what is therein proposed.

And the Right Honourable the Lords Commissioners of the Admiralty are to give the necessary directions herein accordingly.

Notice is hereby given that the Minister of Transport has received an application from the Joint Council for the Retail Distributive Trades Section of the Road Transport Industry, being an organisation representative of employers and workpeople in a section of the road transport industry concerned with the conveyance of goods which the Minister of Labour has certified to be a proper body in respect of the sections of the distributing trades which it represents, to make application for a variation of the periods of time laid down in Section 19 of the Road Traffic Act, 1930, as amended by Section 31 of the Road and Rail Traffic Act, 1933, for the employment of drivers of road vehicles of certain types.

The variation applied for is to the effect that the period of 11 hours laid down in Section 19 (1) (ii.) of the Act of 1930 may be increased to 12 hours on not more than two days in each of the three weeks ending on the 18th December, 25th December 1937, and 1st January 1938, the variation to apply only to those engaged in the delivery of goods from retail shops and/or stores to their customers.

As provided by the Act the Minister has referred the matter to the Industrial Court for advice. The Court has fixed Wednesday, 15th December 1937, at 11 a.m., at No. 5 Old Palace Yard, London, S.W.1, as the time and place for hearing parties to the application.

Copies of the proposals contained in the application for the variation of the periods of time laid down in Section 19 of the Act can be obtained from the Secretary of the Industrial Court at the address given above.

Persons representing organisations of employers or workpeople in the industry who may desire to make representations to the Court in the matter should either give notice beforehand to the Secretary of the Industrial Court that they desire to be heard or submit their representations in writing to the Secretary.
