# PRESENT,

The KING's Most Excellent Majesty in Council.

THEREAS there was this day read at the VV Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 8th day of December 1937

(N. 7344/37), in the words following, viz.:—
"Whereas by section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted inter alia that all pay, pensions or other allowances in the nature thereof payable in respect of services in Your Majesty's Naval or Marine Force to a person being or having been an Officer, Seaman or Marine therein shall be paid in such manner and subject to such restrictions, conditions and provisions as are from time to time directed by Order in Council:

"And whereas Order in Council of 19th May 1931 sanctioned the amalgamation of the Officers' and Ship's Cook branches of the Royal Navy by the creation of a new Continuous Service Naval Cook branch:

"And whereas the aforesaid Order in Council also provided for the continuance, as requisite, of the existing Non-Continuous Service system for Officers' Cooks:

And whereas the entry of Continuous Service Cooks in Your Majesty's Fleet is at present insufficient to meet requirements and we consider it expedient to introduce a system of Non-Continuous Service for Ship's Cook ratings similar to that already in force for

Officers' Cooks:
"And whereas, in consequence of the

Cooks under Order in Council of 7th February 1933, it is necessary to make provision with retrospective effect for the counting of man's service in the Non-Continuous Service ratings of Assistant Steward, Officers' Cook 4th class and Assistant Cook (O) towards triennial increments of pay in the respective ratings of Steward, Officers' Cook 3rd class and Cook (0):

"We beg leave humbly to recommend that Your Majesty may be graciously pleased, by Your Order in Council, to sanction (a) the entry of Cook ratings for Non-Continuous Service with rates of pay as shown in the attached Schedule and (b) the conditions mentioned in the preceding paragraph for the grant of incremental pay to Non-Continuous Service Stewards and Officers' Cooks.

"The Lords Commissioners of Your Majesty's Treasury have signified their concurrence in these proposals.

# PRESENT,

The KING's Most Excellent Majesty in Council.

WHEREAS by subsection (2) of section six of the Hours of Employment (Conventions) Act, 1936 (hereinafter referred to as "the Act"), it is enacted that the Act shall come into force on such day as His Majesty in Council may appoint, and that different days may be appointed for different purposes and different provisions of the Act:

Now, therefore, His Majesty, in pursuance of the powers conferred upon Him by the Act, is pleased by and with the advice of His Privy Council to order, and it is hereby ordered, as

follows:--

- 1. Section three of the Act shall come into force for all purposes on the first day of January nineteen hundred and thirty-eight, and the remainder of the Act, except sections one and two, subsection (1) of section four and Part I. of the Schedule, shall come into force on that day for the purposes of the said section three.
- 2. The whole of the Act, in so far as it is not already in force, shall come into force for all purposes on the twenty-fifth day of January nineteen hundred and thirty-eight.

3. This Order may be cited as the Hours of Employment (Conventions) Act (Commencement) Order, 1937.

WHEREAS the Scottish Education Department have, in the exercise of the powers conferred on them by the Education (Scotland) (Superannuation) Acts, 1919 to 1937, framed a Scheme amending the Superannuation Scheme for Teachers in Scotland approved by His late Majesty King George the Fifth in Council on the 19th day of March 1926 (S.R. & O. 1926 (No. 363), p. 449):

And whereas the said amending Scheme has been laid before each House of Parliament in accordance with the provisions of the said Acts and neither House has presented an Address praying His Majesty to withhold His assent from the said amending Scheme, or any part thereof:

Now, therefore, His Majesty, having taken the said amending Scheme (a copy whereof is hereunto annexed) into consideration, is pleased, by and with the advice of His Privy Council, to approve the same and to order, as it is hereby ordered, that the said amending Scheme shall take effect as from the 13th day of October 1937, with the exception that article 16 thereof shall take effect as from the 13th day of July 1937.

AMENDMENT (1937) OF THE SUPERANNUATION SCHEME FOR TEACHERS (SCOTLAND), 1926, UNDER THE EDUCATION (SCOTLAND) (SUPERANNUATION) ACTS, 1919 TO 1937 (9 & 10 GEO. 5, c. 17; 12 & 13 GEO. 5, c. 48; 14 & 15 GEO. 5, c. 13; 15 & 16 GEO. 5, c. 55; 23 & 24 GEO. 5, c. 22; 25 & 26 GEO. 5, c. 35; 1 EDW. 8 & 1 GEO. 6, c. 47).

Whereas the Scottish Education Department, in the exercise of the powers conferred upon them by section 3 of the Education (Scotland) (Superannuation) Act, 1925, framed an amending Scheme (the Superannuation Scheme for Teachers (Scotland), 1926, hereinafter called "the Scheme", which, after due fulfilment of the procedure prescribed, received approval by Order in Council dated the nineteenth day of March 1926, and came into effect as from the first day of April 1926 (S.R. & O. 1926 (No. 363), p. 449):

And whereas the Scheme was amended by a subsequent scheme made by the Department and approved in like manner by Order in Council dated the twenty-first day of December 1928 (S.R. & O. 1928 (No. 1044), p. 493):

And whereas certain supplementary provisions framed by the Department were added to the Scheme and were approved in like manner by Order in Council dated the seventeenth day of December 1929 (S.R. & O. 1929 (No. 1179), p. 432):

And whereas the Scheme was further amended by subsequent schemes made by the Department and approved in like manner by Orders in Council dated the fifteenth day of December 1932 (S.R. & O. 1932 (No. 1073), p. 471), the twenty-first day of December 1933 (S.R. & O. 1933 (No. 1169), p. 800), and the third day of July 1936 (S.R. & O. 1936 (No. 715):

And whereas by reason of section 4 of the Teachers (Superannuation) Act, 1937, it is necessary that the Scheme be likewise amended:

And whereas it is desirable to amend the Scheme further in certain other respects:

Now, therefore, the Department, in virtue of the powers in that behalf conferred upon them as aforesaid, do amend the Scheme in the following manner:—

- 1.—(a) The following article shall be substituted for article 16 of the Scheme:—
  - 16. If the service of a teacher is discontinued—
    - (i.) for a period not exceeding five years, or not exceeding such longer period as the Department may in the special circumstances of a particular case direct, in the case of a teacher who during that period is employed—
      - (a) as a teacher in any part of His Majesty's dominions outside the United Kingdom; or

- (b) as a teacher in any school in a foreign country which is shown to the satisfaction of the Department to be a school in which it is expedient to facilitate the employment of British teachers; or
- (c) in an educational service outside the United Kingdom in employment which to a substantial extent involves the control or supervision of teachers;
- (ii.) for a period not exceeding one year in any other case;

the said teacher may with the consent of the Department and at such times as they may require pay into the Education (Scotland) Fund in respect of the period during which service was discontinued sums equal to 10 per cent. of his salary as at the date of discontinuing service and, if he so contributes, the said period shall be deemed to be a period of service within the meaning of this Scheme; provided that one-half of any amount paid under this article shall be reckoned as contributions by the teacher, and the remaining half shall be reckoned as having been paid by way of employer's contributions.

- (b) The following articles shall be inserted after article 18 of the Scheme:—
  - 18A.—(1) In such circumstances and subject to such conditions as to proof of good health and other matters as may be prescribed in rules made by the Department under this Scheme, a teacher to whom an annual retiring allowance is granted under the Scheme, otherwise than by reason of infirmity of mind or body, shall be allowed to surrender, as from the date of commencement of the allowance, in return for the benefits of the rules, such part not exceeding one-third of the allowance as may be specified in the rules.
  - (2) In return for the surrender under the foregoing paragraph the Department shall grant, according as the teacher may in conformity with the rules elect, either—
    - (i.) to the spouse or to a dependant of the teacher a pension payable in respect of the period, if any, for which the spouse or dependant survives the teacher; or
    - (ii.) to the teacher an annuity payable as from the date of commencement of the retiring allowance in respect of the period of the joint lives of himself and his spouse and to the spouse a pension payable in respect of the period, if any, for which the spouse survives the teacher:

Provided that the amount of pension granted under (i.) of this paragraph or the amounts of the annuity and pension granted under (ii.) of this paragraph, as the case may be, shall be such that the value, or the aggregate value, thereof shall be actuarially equivalent (according to tables to be prepared from time to time by the Government Actuary), at the date of the commencement of the retiring allowance, to the value of that part of the allowance which is surrendered, so however, that the said amount or amounts shall be reduced to such extent as the Government

Actuary considers sufficient to recoup to the Department the cost, as estimated by them, of administering the provisions of this article.

- 18B.—(1) If any teacher has surrendered part of a retiring allowance in accordance with the foregoing provisions of this Scheme or of any superannuation allowance under the provisions of section 1 of the Teachers (Superannuation) Act, 1937, then—
  - (a) for the purpose of calculating the amount of any supplementary death gratuity which may be granted under article 10 (2) of this Scheme, the sums paid to him and to his legal personal representatives by way of annual retiring allowance within the meaning of that article shall be taken to be the sums which would have been so paid but for the surrender; and
  - (b) for the purpose of computing the balance of his contributions under article 1 (4) of this Scheme, the sums payable under the Scheme to him or to his legal personal representatives (including any sums paid to him or them under the Teachers (Superannuation) Act, 1925), shall be taken to be the sums which would have been so payable but for the surrender.
- (2) If any teacher has surrendered part of a retiring allowance in accordance with the provisions of this Scheme, then for the purpose of determining what reduction shall be made under article 13 (b) in his annual retiring allowance in respect of periods of such employment as is therein mentioned, the annual rate of salary at the date on which he ceased to be employed in service shall be treated as reduced by the amount surrendered.
- (c) The following article shall be substituted for paragraph (2) of article 18 of the Scheme and paragraph (1) of article 18 shall be read as article 18:—
  - 18C. Every assignation of or charge on any retiring allowance, gratuity, pension, or annuity, or on any other sum payable under this Scheme to a teacher or his representatives or to the spouse or dependant of the teacher shall be void, and no such allowance, gratuity, pension, annuity, or sum shall be liable to arrestment or shall, on the sequestration of a person entitled thereto or on the appointment of a judicial factor on his estate under section one hundred and sixty-three of the Bankruptcy (Scotland) Act, 1913 (3 & 4 Geo. 5, c. 20), pass to the trustee or judicial factor, without prejudice, however, to the making of an Order under section one hundred and fortyeight of the said Act or under any similar enactment in England or Northern Ireland.
- (d) The following articles shall be substituted for articles 19 and 20 of the Scheme:—
  - 19. Where any sum not exceeding one hundred pounds is payable under this Scheme, in respect of a retiring allowance, gratuity, or annuity granted to a deceased teacher or of a gratuity granted to the legal personal representatives of a deceased teacher or of a pension granted to a deceased spouse or dependant or by way of the return of any balance of contributions, confirmation

or other proof of title of the legal personal representatives may be dispensed with, and the sum may be paid or distributed to or among the persons appearing to the Department to be beneficially entitled to the personal estate of the deceased teacher or of the deceased spouse or dependant, or to or among any one or more of those persons.

Where the provisions of this Scheme authorise any sum to be paid to the legal personal representatives of a deceased teacher, or where any person to whom any sum is payable under this Scheme has died before payment thereof, and there are no legal personal representatives of such teacher or person, it shall be in the power of the Department to pay the said sum or any part thereof to any dependant of such deceased teacher or person.

- 20.—(1) The Department may from time to time make rules for the purpose of giving effect to the provisions of the Education (Scotland) (Superannuation) Acts, 1919 to 1937, and of this Scheme.
- (2) Any question which arises as to the application of any part of the Scheme to any person, or as to the amount of any payment, gratuity, retiring allowance, pension, or annuity, or as to the return of contributions, or as to the grant, refusal, suspension, or cessation of any such payment, gratuity, allowance, pension, or annuity, or as to the reckoning of any service or salary shall be decided by the Department, whose decision shall be final.
- 2. This amendment may be cited as the Amendment (1937) of the Superannuation Scheme for Teachers (Scotland), 1926.

## TENDERS FOR TREASURY BILLS.

- 1. The Lords Commissioners of His Majesty's Treasury hereby give notice that Tenders will be received at the Bill Office, at the Bank of England, on Friday the 31st December 1937, at 1 o'clock, for Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, and the War Loan Acts, 1914-1919, to the amount of £50,000,000.
- 2. The Bills will be in amounts of £5000 or £10,000. They will be dated at the option of the Tenderer on any business day from Monday the 3rd January 1938 to Saturday the 8th January 1938 inclusive, and will be payable at three months after date.
- 3. The Bills will be issued and paid at the Bank of England.

- 4. Each Tender must be for an amount not iess than £50,000, and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.
- 5. Tenders must be made through a London Banker, Discount House, or Broker.
- 6. The persons whose Tenders are accepted will be informed of the same not later than the following day, and payment in full of the amounts of the accepted Tenders must be made to the Bank of England by means of Cash or a Banker's Draft on the Bank of England not later than 2 o'clock (Saturday 12 o'clock) on the day on which the relative Bills are to be dated
- 7. In virtue of the provisions of Section 1 (4) of the War Loan Act, 1919, Members of the House of Commons are not precluded from tendering for these Bills.
- 8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.
- 9. The Lords Commissioners of His Majesty's Treasury reserve the right of rejecting any Tenders.

REGULATIONS RESPECTING OPEN COMPETITIVE EXAMINATIONS FOR THE EXECUTIVE GROUP OF SITUATIONS, THAT IS TO SAY, FOR THE GENERAL EXECUTIVE CLASS OF THE CIVIL SERVICE, FOR EXECUTIVE BRANCHES OF THE DEFENCE DEPARTMENTS, AND FOR THE SITUA-TIONS OF ASSISTANT AUDITOR IN THE EXCHEQUER AND  $\mathbf{A}\mathbf{u}\mathbf{p}\mathbf{i}\mathbf{r}$ DEPARTMENT, Assistant Examiner in the Estate Duty OFFICE OF THE INLAND REVENUE DEPART-MENT, ACTUARIAL ASSISTANT IN THE DEPART-MENT OF THE GOVERNMENT ACTUARY, AUDIT Assistant in the Ministry of Health, and Assistant Inspector on the Outdoor STAFF OF THE INSURANCE DEPARTMENT OF THE MINISTRY OF HEALTH, THE WELSH BOARD OF HEALTH, AND THE DEPARTMENT OF HEALTH FOR SCOTLAND.

With the exception of posts in executive branches in the Defence Departments, for which men only are eligible, competitions under these regulations are open both to men and

These regulations are liable to alteration from time to time.

1. Candidates must have attained the age of 18 and must not have attained the age of 19 on the first day of March in the year in which the competition is held.

In reckoning age for competition the following allowances will be made, viz .:-

- (a) Candidates who have served or are serving in the Navy, Army, or Air Force may deduct from their actual age any time during which they have so served.
- (b) Candidates who have served in any established civil situation to which they were admitted with the Certificate of the Civil Service Commissioners may deduct from their actual age any time not exceeding two years which they may have spent in such
- 2. Every candidate must be a natural-born British subject, the child of a person who is or was at the time of death a British subject; provided that exception may be made in the case of natural-born British subjects who have satisfactorily completed a period of not less than five years' service on full pay in His Majesty's Regular Forces.

Provided also that if the Civil Service Commissioners are satisfied, in the case of any candidate who is a British subject but does not fulfil all the requirements of the rule as to nationality and descent, that the candidate is so closely connected by ancestry and upbringing with His Majesty's dominions that an exception may properly be made to that rule, they may accept such candidate as eligible provided that this discretion shall not be exercisable unless (a) the father or the paternal grandfather of the candidate was a naturalborn British subject, and (b) neither the father nor the paternal grandfather had acquired any other nationality by naturalisation or by any other voluntary and formal act.

3. No person actually serving in the Navy, Army, or Air Force will be eligible for admission to the examination unless he produces to the Civil Service Commissioners, when called upon to do so, the permission of his Commanding Officer to attend the examination, dated before the commencement of the competition, and given in accordance with such orders as may from time to time be issued.

Persons holding situations in the Civil Service must obtain the permission of the authorities of their Department to attend the examination before the commencement of the

Persons upon whose training for the occupation of teacher public money has been spent cannot be appointed until the consent of the appropriate education authority has been notified to the Civil Service Commissioners.

- 4. Candidates must satisfy the Civil Service Commissioners as to their health and character. Female candidates must be unmarried or widows, and will be required to resign their appointments on marriage.

6. All candidates take subjects 1 to 3. They may also offer any three of the subjects 4 to 17.

7. From the list resulting from an examination will be filled (provided there be candidates duly qualified) the vacancies that have been announced when the result is ready for issue, and such additional vacancies, if any, as it may be decided so to fill.

It will rest with the Civil Service Commissioners to determine the Departments to which the successful candidates shall be assigned. In making the assignments the Commissioners will be guided by the requirements of the public service. Subject to this condition, the wishes of candidates will, where possible, be respected.

To be eligible for assignment as Actuarial Assistant in the Department of the Government Actuary, a candidate must attain such standard in Mathematics in the examination as to satisfy the Civil Service Commissioners.

No candidate will be regarded as qualified for appointment to the Supply Departments of the Admiralty who fails to satisfy the authorities of the Admiralty at an interview with them that he possesses the personal qualifications necessary for the efficient discharge of the duties attached to Executive posts in the Admiralty Supply Departments.

- 8. Application for permission to attend an examination must be made at such times and in such manner as may be fixed by the Civil Service Commissioners.
- 9. A fee of £1 will be required from every applicant for permission to attend an examination; this fee is not returnable in any circumstances. A further fee of £3, being the balance of the prescribed fee of £4, will be required from every candidate attending such examination.

The Civil Service Commissioners further give notice that an Open Competitive Examination will be held under the foregoing Regulations, commencing on the 5th April 1938. The following is a provisional list of the centres at which the examination may be held:—Belfast, Birmingham, Cardiff, Edinburgh, Glasgow, Leeds, London, Manchester, Newcastle-on-Tyne, and Plymouth.

The final list of centres will be decided when the number of candidates desiring examination at each centre is known.

Not fewer than 100 candidates will be appointed on the result of this examination, if so many should be found to be duly qualified.

# MINISTRY OF TRANSPORT. TRUNK ROADS ACT, 1936.
