# FACTORY AND WORKSHOP ACTS, 1901 to 1936.

The Secretary of State for the Home Department hereby gives notice, in pursuance of Section 86 (1) of the Factory and Workshop Act, 1901, that on the 11th February 1938 he made Regulations, under Section 79 of the said Act, to apply to factories and workshops (being print works, bleaching and dyeing works, or works in which cotton or cotton waste is
