TENDERS FOR TREASURY BILLS.

for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

Banker, Discount House, or Broker.

The persons whose Tenders are accepted will be informed of the same not later than the following day, and payment in full of the amounts of the accepted Tenders must be made to the Bank of England by means of Cash or a Banker's Draft on the Bank of England not later than 2 o'clock (Saturday 12 o'clock) on the day on which the relative Bills are to be dated.
- 7. In virtue of the provisions of Section 1 (4) of the War Loan Act, 1919, Members of the House of Commons are not precluded from tendering for these Bills.

THE LOCAL GOVERNMENT (KILMARNOCK TOWN COUNCIL) ORDER (SCOTLAND), 1938, DATED 4TH APRIL 1938, MADE BY THE SECRETARY OF STATE UNDER THE LOCAL GOVERNMENT (SCOTLAND) ACT, 1929 (19 AND 20 GEO. 5, c. 25).

WHEREAS it has been represented to the Secretary of State by the Town Council of the Burgh of Kilmarnock (hereinafter referred to as "the burgh") that he should make an Order under Section 36 (1) of the Local Government (Scotland) Act, 1929, with reference to the number of councillors and to the boundaries of the wards of the burgh:

And whereas it is expedient to give effect to the said representation:

Now therefore the Secretary of State in exercise of the powers conferred upon him by Section 36 (1) of the Local Government (Scotland) Act, 1929, hereby orders as follows:—

- 1. The burgh shall be divided into eight wards as set forth in the Schedule to this Order.
- 2. The existing councillors for the First, Second, Third, Fourth, Fifth, Sixth, Seventh, and Eighth Wards of the burgh shall be apportioned to and deemed to have been elected for the Dean, Hillhead, Central, Bonnyton, Grange, Netherton, Loanhead, and Riccarton Wards as constituted by this Order respectively.
- 3. On and after the first Tuesday of November 1938 the number of councillors of the burgh shall be twenty-four, and there shall be three councillors for each ward.
- 4. On the first Tuesday of November 1938 the two councillors for the Central Ward who have been longest in office since their last election shall retire from office; and at the election of councillors to be held in the year 1938 such a number of councillors shall be elected for the Central Ward as shall provide the number determined by this Order.
 - 5. This Order may be cited as the Local

Government (Kilmarnock Town Council) Order (Scotland), 1938.

SCHEDULE.

Dean Ward.

That part of the burgh included within the line drawn from the point where the boundary of the burgh crosses the centre of the Glasgow Road; thence along the eastern boundary of the burgh to the centre of London Road; thence in a westerly direction along the centre of London Road to the centre of the Kilmarnock Water at the London Road Bridge; thence in a northerly direction along the centre of the Kilmarnock Water, a distance of 500 feet or thereby to a point due east of the junction of Ladeside and Green Street; thence in a westerly direction to the centre of Ladeside at its junction with Green Street; thence in a southerly direction along the centre of Green Street to its junction with Clerk's Lane; thence in a westerly and south-westerly direction along the centre of Clerk's Lane to its junction with New Street; thence in a westerly direction along the centre of New Street and East George Street to its junction with Portland Street; thence in a northerly direction along the centre of Portland Street, Wellington Street, Dean Street, Beansburn, and Glasgow Road to the point of commencement.

Hillhead Ward.

That part of the burgh included within the line drawn from the point where the boundary of the burgh crosses the centre of the Glasgow Road; thence in a southerly direction along the centre of Glasgow Road, Beansburn, and Dean Street to its junction with Witch Road; thence in a westerly direction along the centre of Witch Road, Hill Street, High Bonnyton Road to the Railway Bridge over the London Midland and Scottish Railway (Glasgow-Barrhead-Kilmarnock Joint Line); thence in a westerly direction along the North side of the said railway to the point where the boundary of the burgh crosses the said railway at enclosure No. 790; thence along the western and northern boundary of the burgh to the point of commencement.

Central Ward.

That part of the burgh included within the line drawn from a point in the centre of Portland Street at its junction with East George Street; thence along the south-western boundary of the Dean Ward to the bridge carrying London Road over the Kilmarnock Water; thence in a southerly and westerly direction along the centre of the Kilmarnock Water to the centre of the bridge carrying Green Street over the Kilmarnock Water; thence southerly along the centre of Sturrock Street and Clark Street to its junction with Fowlds Street; thence in a westerly direction along the centre of

Fowlds Street to its junction with King Street; thence in northerly direction along the centre of King Street to its junction with St. Marnock Street; thence in a westerly direction along the centre of St. Marnock Street and Portland Road to the centre of the Railway Bridge carrying the London Midland and Scottish Railway (Kilmarnock and Troon Branch) over Portland Road; thence in a northerly direction along the centre of the said railway to the bridge carrying the said railway over Bonnyton Road; thence in an easterly direction along the centre of Bonnyton Road, West Langland Street, and West George Street to the point of commencement.

Bonnyton Ward.

That part of the burgh included within the line drawn from a point in the centre of Portland Street at its junction with West George Street; thence along the northern and western boundary of the Central Ward to the centre of the bridge carrying the London Midland and Scottish Railway (Kilmarnock-Troon branch) over Portland Road; thence in a westerly direction along the centre of Irvine Road to the boundary of the burgh; thence along the western boundary of the burgh to its junction with the southern boundary of the Hillhead Ward; thence along the latter boundary of the Dean Ward; thence along the last mentioned boundary to the point of commencement.

Grange Ward.

That part of the burgh included within the line drawn from a point in the centre of King Street at its junction with St. Marnock Street and thence in a southerly direction along the centre of King Street and Titchfield Street to its junction with Douglas Street; thence in a westerly direction along the centre of Douglas Street to the centre of Kilmarnock Water; thence in a south and south-westerly direction along the centre of the Kilmarnock Water to its junction with the River Irvine; thence generally in a westerly direction along the centre of the River Irvine to the boundary of the burgh; thence along the western boundary of the burgh to its junction with the southern boundary of the Bonnyton Ward; thence in an easterly direction along the centre of Irvine Road, Portland Road, and St. Marnock Street to the point of commencement.

Netherton Ward.

That part of the burgh included within the line drawn from a point in the centre of Armour Street at its junction with Titchfield Street; thence in an easterly and north-easterly direction along the centre of Armour Street and Gilmour Street to its junction with Old Mill Road; thence in an easterly and south-easterly direction along the centre of Old Mill Road and Welbeck Street to the centre of the River Irvine at the point where the bridge carrying Queen's Drive crosses the river; thence in a south-westerly, southerly, and westerly direction following the bends along the centre of the River Irvine to its junction with the Kilmarnock Water; thence in a northerly direction along the centre of Douglas Street; thence in an easterly direction along the centre of Douglas

Street to its junction with Titchfield Street; thence in a southerly direction along the centre of Titchfield Street to the point of commencement.

Loanhead Ward.

That part of the burgh included within the line drawn from the centre of London Road Bridge, carrying London Road over the Kilmarnock Water; thence in an easterly direction along the centre of London Road to the boundary of the burgh; thence along the eastern boundary of the burgh to the centre of the River Irvine; thence in a south-westerly, northwesterly, and westerly direction following the bends along the centre of the River Irvine to the point where the bridge carrying Queen's Drive crosses the river; thence along the eastern and northern boundary of the Netherton Ward to the centre of Titchfield Street; thence in a mortherly direction along the centre of Titchfield Street to its junction with Fowlds Street; thence along the southern and eastern boundary of the Central Ward to the point of commencement.
