## TENDERS FOR TREASURY BILLS.

1. The Lords Commissioners of His Majesty's Treasury hereby give notice that Tenders will be received at the Bill Office, at the Bank of England, on Friday the 29th April 1938, at 1 o'clock, for Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, and the War Loan Acts, 1914-1919, to the amount of £45,000,000.

2. The Bills will be in amounts of £5000 or £10,000. They will be dated at the option of the Tenderer on any business day from Monday the 2nd May 1938 to Saturday the 7th May 1938 inclusive, and will be payable at three months after date.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000, and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House, or Broker.

6. The persons whose Tenders are accepted will be informed of the same not later than the

following day, and payment in full of the amounts of the accepted Tenders must be made to the Bank of England by means of Cash or a Banker's Draft on the Bank of England not later than 2 o'clock (Saturday 12 o'clock) on the day on which the relative Bills are to be dated.

7. In virtue of the provisions of Section 1 (4) of the War Loan Act, 1919, Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.

9. The Lords Commissioners of His Majesty's Treasury reserve the right of rejecting any Tenders.

**MERCHANDISE MARKS ACT, 1926.**

**REFERENCE TO THE STANDING COMMITTEE.**

In accordance with the provisions of Sub-Section (4) of Section 2 of the Merchandise Marks Act, 1926, the Board of Trade give notice that, in pursuance of an application received by them for the making of an Order in Council to require imported goods of certain classes and descriptions to bear an indication of origin, they have made a reference to the Standing Committee appointed by them under the Act in respect of the following descriptions of imported goods:—

Solid-headed pins of brass, iron or steel.

Attention is called to the fact that while, under the provisions of the above Act, the Committee must in every case referred to them consider whether the goods should bear an indication of origin at the time of sale or exposure for sale, they may also at their discretion consider and report upon the question whether such goods should bear an indication of origin at the time of importation.

**SPORTING CARTRIDGE CASES.**

With reference to the Notice which was published in the London, Edinburgh, and Belfast Gazettes of the 1st October 1937 regarding a reference made by the Board of Trade to the Standing Committee under the Merchandise Marks Act, 1926, in respect of sporting cartridge cases, the Board of Trade hereby give notice in accordance with the provisions of Sub-Section (7) of Section 2 that a report has been made by the Committee in respect of the aforesaid description of goods.

The Civil Service Commissioners hereby give notice that the following Regulations are published with the approval of the Lords Commissioners of His Majesty's Treasury, viz.:—

**REGULATIONS RESPECTING COMPETITIVE EXAMINATIONS FOR THE ESTABLISHED SITUATION OF EX-SOLDIER CLERK, GRADE B, IN THE WAR OFFICE.**

These Regulations are liable to alteration from time to time.

1. The upper limit of age for these situations

is 49, and candidates must be under that age on the first day of the month in which the competition is held.

2. At each examination the number of candidates to be selected will be such as may from time to time be fixed.

3. In order to be eligible a candidate must on the first day of the month in which the examination is held—

(a) have been discharged from the Regular Army on termination of engagement after not less than 12 years' service with the Colours, or have been invalided out;

(b) have left the Colours not more than two years;

(c) be in possession of at least a 1st Class Certificate of Education and an Army Certificate of Character marked " Exemplary " or " Very Good." Candidates otherwise eligible, in whose cases exemption from obtaining a First Class Certificate of Education was granted with due War Office authority, will be regarded as eligible under this Clause.

4. Candidates will be required to satisfy the Civil Service Commissioners that they are duly qualified in respect of health and character.

5. Every candidate must be a natural-born British subject, the child of a person who is or was at the time of death a British subject; provided that exception may be made:—

(a) In the case of candidates serving in a civil situation to which they were admitted with the Certificate of the Civil Service Commissioners.

(b) In the case of natural-born British subjects who served in His Majesty's Armed Forces in the Great War between 4th August 1914 and 11th November 1918.

(c) In the case of natural-born British subjects who have satisfactorily completed a period of not less than five years' service on full pay in His Majesty's Regular Forces.

Provided also that if the Civil Service Commissioners are satisfied, in the case of any candidate who is a British subject but does not fulfil all the requirements of the rule as to nationality and descent, that the candidate is so closely connected by ancestry and upbringing with His Majesty's dominions that an exception may properly be made to that rule, they may accept such candidate as eligible provided that this discretion shall not be exercisable unless (a) the father or the paternal grandfather of the candidate was a natural-born British subject, and (b) neither the father nor the paternal grandfather had acquired any other nationality by naturalisation or by any other voluntary and formal act.

The consent of the authorities of the War Office is required before a candidate either of whose parents was of other than British nationality at birth can be appointed to that Department.

6. Persons holding situations in the Civil Service must obtain the permission of the authorities of their Department to attend the examination before the commencement of the competition.

7. The examination will be in the following subjects, viz.:—

- English.
- Arithmetic.
- Geography.
- General Knowledge.

Candidates will be required to obtain such an aggregate of marks in the examination as a whole as to satisfy the Civil Service Commissioners.

8. Of the vacancies to be filled from any examination a number may be reserved for competition among candidates with Army service in particular Corps, the remainder being open to candidates from all units of the Army. Any additional vacancies which may occur and which it is decided to fill on the result of the examination may be offered to candidates next in order of merit either on the list for the reserved vacancies referred to above or on the general list, as may be required.

9. Application for permission to attend an examination must be made at such times and in such manner as may be fixed by the Civil Service Commissioners.

10. A fee of £1 will be required from every candidate attending an examination.

The Civil Service Commissioners further give notice that a Competitive Examination will be held under the foregoing Regulations on the 19th July 1938.

The following is a provisional list of the centres at which the examination may be held:—Aberdeen, Belfast, Birmingham, Bristol, Cardiff, Chester, Darlington, Edinburgh, Exeter, Glasgow, Hull, Leeds, Liverpool, London, Manchester, Newcastle-on-Tyne, Norwich, Nottingham, Plymouth, Portsmouth, Preston, Salisbury, Sheffield, Stoke-on-Trent, Swansea, and York.

The final list of centres will be decided when the number of candidates desiring examination at each centre is known.

The anticipated number of vacancies which will be available to be filled from the examination is twenty-five, if so many candidates should be found to be duly qualified.

No person will be admitted to examination from whom the Secretary of the Civil Service Commission has not received on or before the 26th May 1938 an application in the candidate's own handwriting, on a prescribed form, which may be obtained from the Secretary at once.
