#### PRESENT,

WHEREAS by Section 5 of the Merchant Shipping (Mercantile Marine Fund)
Act, 1898 (61 & 62 Vict. c. 44) (hereinafter referred to as "the said Section"), it is, amongst other things, enacted as follows:-

- " 5.—(1) On and after the commencement of this Act the general lighthouse authorities shall levy light dues with respect to the voyages made by ships or by way of periodical payment and not with respect to the lights which a ship passes or from which it derives benefit and the dues so levied shall take the place of the dues now levied by those authorities.
- (2) The scale and rules set out in the Second Schedule to this Act shall take effect for the purpose of the levying of light dues in pursuance of this Act but Her Majesty may by Order in Council alter either generally or with respect to particular classes of cases the scale or rules and the exemptions therefrom."

And whereas by the Merchant Shipping (Light Dues) Order, 1937, certain alterations were made in the Scale and Rules set out in the Section Schedule to the said recited Act:

And whereas it is expedient that such last recited Order should be revoked:

And whereas it has been made to appear to His Majesty that the said Scale and Rules should be further altered in manner hereinafter appearing:

Now, therefore, His Majesty, in exercise of the powers vested in Him by the said Section and of all other powers enabling Him in that behalf and by and with the advice of His Privy Council, doth order, and it is hereby ordered, as follows:—

- 1.—(a) This Order may be cited as the Merchant Shipping (Light Dues) Order, 1938, and shall have effect from the first day of April 1938, or from the date of its publication in the London Gazette, whichever date shall be the later.
- (b) The Interpretation Act, 1889 (52 & 53 Vict. c. 63), shall apply to the interpretation of this Order as it applies to the interpretation of an Act of Parliament.
- 2. Each of the dues authorised to be levied in accordance with the Scale set out in the Second Schedule to the said recited Act shall be subject to an increase of 30 per cent. for the purpose of the levying of light dues in pursuance of the said recited Act.
- 3. The payments referred to in the proviso to Rule (1) and in the proviso to Rule (7) of the Rules set out in the Second Schedule to the said recited Act shall also be subject to an increase of 30 per cent.
- 4. The Merchant Shipping (Light Dues) Order, 1937, is hereby revoked.

- 7. Factories (intervals for women and young persons) regulations, prescribing, under Section 84 of the Act, conditions subject to which the women and young persons employed in a factory need not all be allowed the same intervals for meals or rest.

Factories Act (Docks, Building, and Engineering Construction, &c.) modification regulations, modifying or adapting (a) the provisions of the Act as to general registers, in their application to docks, wharves, quays, and warehouses (Section 105), and to building operations and works of engineering construction (Sections 107 and 108); and (b) the provisions of the Act as to steam boilers and air receivers in their application to building operations and works of engineering construction.

- 1. Factories (Cleanliness of Walls & Ceilings) Order, partly exempting certain classes of factory from section 1 (c) of the Act.
- 2. Local Authorities (Transfer of Enforcement) Order, the effect of which is that the Factory Inspectors, instead of the District Councils, will enforce certain general health provisions in Part I. of the Act in the case of works subject to certain codes of special

regulations specified in the Schedule to the Order.

3. Dangerous Machines (Training of Young Persons) Order, prescribing certain machines at which, owing to their dangerous character, young persons must not work unless the requirements of section 21 of the Act as to training and supervision are complied with.

4. Hoists Exemption Order, exempting, subject to conditions and limitations, certain classes or descriptions of hoist or hoistway from certain of the requirements of section 22

of the Act as specified in the Order.

The Civil Service Commissioners hereby give notice that the following Regulations are published with the approval of the Lords Commissioners of His Majesty's Treasury, viz.:—

REGULATIONS RESPECTING COMPETITIVE EXAMINATIONS AMONG MEMBERS OF THE MINOR AND MANIPULATIVE GRADES OF THE CIVIL SERVICE FOR APPOINTMENT TO THE CLERICAL CLASSES (GENERAL AND DEPARTMENTAL) OF THE CIVIL SERVICE.

Competitions under these Regulations are open both to male and female candidates. The Regulations are liable to alteration from time to time.

1. Candidates must at the time of the examination be established members of the Minor and Manipulative Grades of the Civil Service within the scope of the National Whitley Council, or members of an unestablished grade corresponding to an established grade the members of which are eligible for admission to the examination; provided that Writing Assistants and Clerical Assistants and members of the typing grades will not be eligible to compete.

2. Candidates must by the first day of the examination either (a) have had not less than three years' full-time service on duties proper to an adult class, or (b) have attained the age of 22 and have had not less than one year's full-time service on duties proper to an adult class. The service in each case must have been

continuous.

3. Candidates must not have attained the age

of 30 on the 1st March or the 1st September of the year in which they are examined, according as the examination is held in the first or second half of the year.

4. Every candidate must be a natural-born British subject, the child of a person who is or was at the time of death a British subject; provided that exception may be made in the case of natural-born British subjects who have satisfactorily completed a period of not less than five years' service on full pay in His Majesty's Regular Forces.

Provided also that if the Civil Service Commissioners are satisfied, in the case of any candidate who is a British subject but does not fulfil all the requirements of the rule as to nationality and descent, that the candidate is so closely connected by ancestry and upbringing with His Majesty's dominions that an exception may properly be made to that rule, they may accept such candidate as eligible provided that this discretion shall not be exercisable unless (a) the father or the paternal grandfather of the candidate was a natural-born British subject, and (b) neither the father nor the paternal grandfather had acquired any other nationality by naturalisation or by any other voluntary and formal act.

- 5. Persons upon whose training for the occupation of teacher public money has been spent cannot be appointed until the consent of the appropriate education authority has been notified to the Civil Service Commissioners.
- 6. Candidates will be required to satisfy the Civil Service Commissioners that they are duly qualified in respect of health and character; female candidates must be unmarried or widows and will be required to resign their appointments on marriage.
- 7. The examination will be in the following subjects:—
  - 1. English.
  - 2. Arithmetic.
  - 3. General Knowledge.
  - 4. One of the following:—
    Mathematics; French; German; History; Geography; Economics.

Candidates must obtain such an aggregate number of marks in the examination as a whole as to satisfy the Civil Service Commissioners.

- 8. It will rest with the Civil Service Commissioners to determine the Departments to which the successful candidates shall be assigned. In making assignments the Commissioners will be guided by the requirements of the public service and will have regard, so far as vacancies permit, to the previous Departmental experience of the candidates and the wishes of Departments for the assignment of particular candidates who have served under them. Subject to these conditions the wishes of candidates will, where possible, be respected.
- 9. Successful candidates will be subject to a strict probation extending over a period of not less than one year; and failure to pass this probation will involve reversion.
- 10. Application for permission to attend an examination must be made at such times and in such manner as may be fixed by the Civil Service Commissioners; the application must be

accompanied by a certificate from the authorities of the Department in which the candidate is serving, in the space provided on the application form, that he (or she) satisfies the conditions laid down in clauses 1 and 2 of these regulations and that his (or her) service has been approved.

11. A fee of £1 10s. will be required from each candidate attending an examination.

The Civil Service Commissioners further give notice that a Competitive Examination will be held under the foregoing Regulations, commencing on the 6th October 1938.
