WHEREAS there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 19th day of September 1938 (C.W. 10948/38) in the words following, viz.:—

"Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted, inter alia, that all pay, pensions, or other allowances in the nature thereof payable in respect of services in Your Majesty's Naval or Marine Force to a person being or having been an Officer, Seaman, or Marine therein, shall be paid in such manner and subject to such restrictions, conditions, and provisions as are from time to time directed by Order in Council:

"And whereas by Order in Council dated the 24th day of February 1938 Your Majesty was pleased to approve the institution of a special category of Officers to be employed on air duties in Your Majesty's Fleet:

"And whereas we are of opinion that the requirements of the Air Arm of Your Majesty's Fleet necessitate provision for the employment of such Officers on observing duties:

"We beg leave humbly to recommend that Your Majesty may be graciously pleased by Your Order in Council to approve the allowances set forth in the enclosed Schedule accordingly. "The Lords Commissioners of Your Majesty's Treasury have signified their concurrence in this proposal.

"(b) Midshipmen (A) whilst undergoing courses of instruction for observer duties to be eligible for an allowance of 3s. for each day on which they make an ascent in aircraft.

"(c) Midshipmen (A) after qualifying as observer, to be eligible for an allowance of 4s. a day, to be paid continuously whilst they hold appointments for observers duties."

His Majesty, having taken the said Memorial into consideration, was pleased, by and with the advice of His Privy Council, to approve of what is therein proposed.

which Institution and bodies are organisations representative of employers in a section of the road transport industry concerned with the conveyance of goods which the Minister of Labour has certified to be proper bodies, in respect of the branches of the industry which they represent, to make application for a variation of the periods of time laid down in Section 19 of the Road Traffic Act, 1930, as amended by Section 31 of the Road and Rail Traffic Act, 1933, for the employment of drivers of road vehicles of certain types.

The variation applied for is to the effect that the period of 11 hours laid down in Section 19 (1) (ii.) of the Act of 1930 may be increased to 12 hours on not more that two days in each of the three weeks ending on the 17th, 24th, and 31st December 1938, the variation to apply only to the drivers of vehicles whose use is authorised under a "C" carrier's licence granted under Part I. of the Road and Rail Traffic Act, 1933. The Associates Committee of the British Road Federation suggest that any Order made should be of a permanent nature applicable to successive Christmas seasons.

As provided by the Act the Minister has referred the matter to the Industrial Court for advice. The Court has fixed Tuesday, 22nd November, at 11 a.m., at 1 Abbey Garden, Great College Street, London, S.W.1, as the time and place for hearing parties to the applications.

Copies of the proposals contained in the applications for the variation of the periods of time laid down in Section 19 of the Act can be obtained from the Secretary of the Industrial Court at the address given above.

Persons representing organisations of employers or workpeople in the industry who may desire to make representations to the Court in the matter should either give notice beforehand to the Secretary of the Industrial Court that they desire to be heard or submit their representations in writing to the Secretary.
