WHEREAS there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 29th day of October, 1938 (N. 6186/38) in the words following viz:—

"Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted, inter alia, that all pay, pensions, or other allowances in the nature thereof payable in respect of services in Your Majesty's Naval or Marine Force to a person being or having been an Officer, Seaman, or Marine therein shall be paid in such manner and subject to such restrictions, conditions, and provisions as are from time to time directed by Order in Council:

"And whereas Your Majesty was graciously pleased, by Your Order in Council bearing date the 28th day of July 1938 to sanction revised rates of non-substantive pay for Gunnery ratings in the Royal Navy and Royal Marines:

ratings in the Royal Navy and Royal Plannes. "And whereas we consider that an allowance of 6d. a day, to be called 'Instructional Allowance,' should be granted to Quartermaster Sergeant Instructors of Gunnery, Royal Marines, with effect from the date on which the arrangements under Order in Council of 28th July become effective:

"We beg leave humbly to recommend that Your Majesty may be graciously pleased, by Your Order in Council, to sanction payment accordingly. "The Lords Commissioners of Your-Majesty's Treasury have signified their concurrence in this proposal."

His Majesty, having taken the said Memorial into consideration, was pleased, by and with the advice of His Privy Council, to approve of what is therein proposed.

And the Right Honourable the Lords Commissioners of the Admiralty are to give the necessary directions herein accordingly.

#### PRESENT,

The KING's Most Excellent Majesty in Council.

WHEREAS by Section 80 of the Merchant Shipping Act, 1906, power is given to-His Majesty by Order in Council to make Regulations with respect to the manner in which Government ships may be registered as British ships for the purpose of the Merchant Shipping Acts:

And whereas by the said Section it is provided that those Acts shall, subject to any exceptions and modifications which may be made by Order in Council, either generally or as respects any special class of Government ships, apply to Government ships registered in accordance with such Regulations as if they were registered in manner provided by those Acts:

And whereas the provisions of Section 1 of the Rules Publication Act, 1893 (56 & 57 Vict.

c. 66) have been complied with:

Now, therefore, Ĥis Majesty, by virtue of the powers in this behalf by the said Act, or otherwise in Him vested, is pleased, by and with the advice of His Privy Council, to order, and it is hereby ordered, that the following Regulations shall have effect as regards any Government ships in the service of the Government of the Colony of Fiji (hereinafter referred to as the Colonial Government):—

- 1. An application for registry of a Government ship in the service of the Colonial Government shall be made in writing under the hand of the Colonial Secretary of Fiji or other officer of the Colonial Government nominated by the Governor, or by one of the Crown Agents for the Colonies. Such application shall contain the following particulars:—
  - (i.) A statement of the name and description of the ship.
  - (ii.) A statement of the time when and place where the ship was built, or, if the ship was foreign built, and the time and place of building are unknown, a statement to that effect and of her foreign name.
  - (iii.) A statement of the nature of the title to the said ship, whether by original construction by or for the Colonial Government, or by purchase, capture, condemnation, or otherwise, and a list of the documents of title, if any, in case she was not originally constructed by or for the Colonial Government.
  - (iv.) A statement of the name of the Master.
- 2. The Registrar, on receiving such application in respect of a Government ship in the service of the Colonial Government shall—
  - (i.) enter the ship in the Register Book as belonging to "His Majesty, represented by the Government of the Colony of Fiji" and shall also enter therein:
  - (ii.) the name of the port to which she belongs;
  - (iii.) the particulars stated in the application for registration;
  - (iv.) the details comprised in the Surveyor's Certificate.
- 3. On the registry of a Government ship in the service of the Colonial Government the Registrar shall retain in his possession the Surveyor's Certificate and the application for registry and any documents of title mentioned in such application.
- 4. Upon the transfer of a registered Government ship in the service of the Colonial Government by Bill of Sale, the Colonial Government shall be the transferors, and the Bill of Sale shall be a Form A in the proper form prescribed under the Merchant Shipping Act, 1894 (57 & 58 Vict. c. 60), hereinafter called the principal Act, omitting the covenant therein contained. Any such Bill of Sale shall be signed by the Colonial Secretary or other officer or Crown Agent as aforesaid on behalf of the Colonial Government.

5. The application for a Certificate of Sale referred to in Sections 39 to 42 and Sections 44 to 46 of the principal Act, may be made in

respect of a Government ship in the service of the Colonial Government by the Colonial Secretary or other officer or Crown Agent as aforesaid on behalf of the Colonial Government.

6. The person to whom the management of any Government ship in the service of the Colonial Government is entrusted by the Colonial Government shall be registered as provided by Section 59 (2) of the principal Act.

7. Where any provision of the Merchant Shipping Acts which by virtue of the Merchant Shipping Act, 1906, and this Order in Council is applicable to Government ships in the service of the Colonial Government imposes any duty or liability or confers any right or power upon or contemplates any act being performed by the owner of a ship such duty, liability, right, or power shall, subject always to the other provisions of this Order in Council, be carried out, borne, or exercised by the Colonial Government on behalf of His Majesty.

8. In this Order in Council the term Merchant Shipping Acts shall mean and include any of the Merchant Shipping Acts, any provision of which is by virtue of the Merchant Shipping Act, 1906, and this Order, applicable

to Government ships.

9. The following sections and provisions of the Merchant Shippings Acts shall not apply to Government ships in the service of the Colonial Government registered in pursuance of this Order, namely:—

- (i.) The Merchant Shipping Act, 1894—Sections 1, 8 to 12. The provisions of Part II. of the Act relating to the requirement of officers to hold certificates of competency and the production of these certificates.
- (ii.) The Merchant Shipping (Mercantile Marine Fund) Act, 1898 (61 & 62 Vict. c. 44)
  —Sections 3 and 5.
- (iii.) The Merchant Shipping Act, 1906—Sections 25 and 27.

Provided always that no provision of the Merchant Shipping Acts which, according to a reasonable construction, would not apply in the case of Government ships in the service of the Colonial Government, shall be deemed to apply to such ships by reason only that its application is not hereby expressly excluded.

10. Anything required or authorised by this Order in Council to be done by the Colonial Government may be done by the Colonial Secretary or other officer or Crown Agent as

aforesaid.

And whereas Notice of the said Representation and of the time when it pleased His Majesty to order the same to be taken into consideration by the Privy Council has been duly published in the Edinburgh Gazette, and fixed in manner required by the said Order in Council:

#### ARCHITECTS (REGISTRATION) ACT, 1931.

A Regulation made by the Architects Registration Council of the United Kingdom under Section 13 of the above-mentioned Act has been submitted for the approval of the Privy Council and is published herewith.

Representations by persons to whom the Regulation is applicable may be made in writing to the Privy Council Office on or before the 26th day of November 1938.

THE ARCHITECTS REGISTRATION COUNCIL OF THE UNITED KINGDOM.

Regulation made in pursuance of Section 13 of the Architects (Registration) Act, 1931, amending the existing Regulations.

Throughout the existing Regulations insert Principal "before "Act" wherever the "Principal" before "Act" wherever the word "Act" occurs, except in Regulation 1 (1) and (2) and Regulation 27.

Regulation 1 (1). In the first paragraph for "the Act" substitute "the Acts" and for "The Architects (Registration) Act, 1931" substitute "The Architects (Registration) Acts, 1931 to 1938," At the end of the first paragraph insert "The expression Principal Act means the Architects (Registration) Act, 1931.

36.—(a) Applications for registration under Section 6 of the principal Act.

The fee to be paid by an applicant shall be ten shillings for the years 1939 and 1940 respectively and thereafter six shillings and eightpence. The said fee shall be paid by the applicant at the time of his application but shall be repaid to him in the event of his application being refused.

(b) Applications for registration under Section 2 of the Architects Registration Act, 1938.

The fee to be paid by the applicant shall be ten shillings for the years 1939 and 1940 respectively and thereafter six shillings and eightpence. The said fee shall be paid by the applicant at the time of his application but shall be repaid to him in the event of his application being refused.

37. The retention fee mentioned in Section 13 of the principal Act shall be ten shillings for the years 1939 and 1940 respectively and thereafter six shillings and eightpence. The sum by way of penalty mentioned in subsection (5) of that section shall be ten shillings, provided that the Council after considering the circumstances affecting any particular case may remit the whole or any part of such penalty.
