The KING has been pleased, by Royal Warrant bearing date the 1st instant, to authorise the Royal Commission on Ancient and Historical Monuments and Constructions in Scotland to extend the inventory for the City of Edinburgh so as to include such Monuments and Constructions from the year 1707 to the year 1815 as may seem to them worthy of mention therein.

#### TENDERS FOR TREASURY BILLS.

1. 7. In virtue of the provisions of Section 1 (4) of the War Loan Act, 1919, Members of the House of Commons are not precluded from tendering for these Bills.

### IMPORT DUTIES ACT, 1932, AND FINANCE ACT, 1933.

Whereas it is provided by sub-section (1) of Section 9 of the Import Duties Act, 1932 (22 Geo. 5, ch. 8), that, with a view to obtaining information as to the condition and progress of trades and industries engaged in the manufacture in the United Kingdom of goods of a class or description which, if they were imported into the United Kingdom, would be chargeable with a duty of Customs under Part I. of that Act, the Board of Trade may, before the commencement of the year nineteen hundred and thirty-three and any subsequent year, publish in the Gazette notice that they will require returns in relation to that year in accordance with the provisions of the said section:
