"Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted, *inter alia*, that all pay, pensions, or other allowances in the nature thereof, payable in respect of services in Your Majesty's Naval or Marine Force to a person being or having been an Officer, Seaman, or Marine therein, shall be paid in such manner, and subject to such restrictions, conditions, and provisions, as are from time to time directed by Order in Council:

"And whereas we consider it necessary to train naval ratings, other than those belonging to the Sailmaker branch of the Royal Navy, as Fabric Workers to undertake duties connected with the fabric and canvas of aircraft:

"And whereas in consideration of the duties to be performed we consider it necessary to provide non-substantive pay at the rate of sixpence a day to be pay ble to such naval ratings as have been trained as Fabric Workers:

"We beg leave humbly to recommend that Your Majesty by Your Order in Council may be graciously pleased to sanction payment accordingly.

"The Lords Commissioners of Your Majestv's Treasury have signified their concurrence in the above proposal."
