PARLIAMENTARY ELECTIONS, SCOTLAND.

THE PLACES OF ELECTION (SCOTLAND) ORDER, 1939, DATED APRIL 12, 1939, MADE BY THE SECRETARY OF STATE UNDER SECTION 43 (16) OF THE REPRESENTATION OF THE PEOPLE ACT, 1918 (7 & 8 Geo. 5, c. 64), SUBSTITUTING NEW PLACE OF ELECTION FOR THE PARLIAMENTARY CONSTITUENCY OF BUTE AND NORTHERN DIVISION OF THE PARLIA-MENTARY COUNTY OF AYR AND BUTE.

Whereas by Sub-section (16) of Section 43 of the above Act it is provided that, in the case of parliamentary elections (other than an election for a university constituency) the place of election shall be a convenient room situated in such place as the Secretary for Scotland may by Order from time to time determine:

Now therefore, I, the Right Honourable John Colville, T.D., One of His Majesty's Principal Secretaries of State, do hereby order, in pursuance of the powers conferred upon me by the provision above recited as read with the Secretaries of State Act, 1926 (16-7 G. 5, c. 18), that the Schedule to the Places of Election (Scotland) Order, 1918, shall be further amended by the substitution in Part II. of Ayr for Kilwinning as the Place of Election for the Bute and Northern Division of Ayr and Bute.

This Order may be cited as the Places of Election (Scotland) Order, 1939.

REGULATIONS RESPECTING A SPECIAL LIMITED COMPETITION FOR THE SITUATIONS OF TYPIST AND CLERK-TYPIST (FEMALE) IN DEPARTMENTS OF THE CIVIL SERVICE.

1. Candidates must have completed six months' continuous service in a British Government Department immediately prior to the last day for the receipt of applications for the competitions in one or more of the following capacities, viz.:—Temporary Typist; Temporary Clerk-Typist; Temporary Shorthand Typist; Temporary Clerk-Shorthand Typist.

A candidate who has completed six months' continuous service in a British Government Department in one or more of the above capacities terminating on a date between the 26th January 1939 and the last day for the receipt of applications will not be regarded as ineligible provided she is re-employed in one of those capacities in the same Department after a break not exceeding one month and continues to be so employed up to the last day for the receipt of applications.

2. No candidate will be eligible for admission to the examination whose age on the last day for the receipt of applications exceeds 50 years.

3. Candidates will be required to satisfy the Civil Service Commissioners—

- (a) That they are unmarried or widows.
- (b) That they are duly qualified in respect of health and character.
- 4. Every candidate must be a natural-born British subject, the child of a person who is or was at the time of death a British subject.

Provided that if the Civil Service Commissioners are satisfied in the case of any candidate who is a British subject but does not fulfil all the requirements of the rule as to nationality and descent, that the candidate is so closely connected by ancestry and upbringing with His Majesty's dominions that an exception may properly be made to that rule, they may accept such candidate as elligible provided that this discretion shall not be exercisable unless (a) the

father or the paternal grandfather of the candidate was a natural-born British subject, and (b) neither the father nor the paternal grandfather had acquired any other nationality by naturalisation or by any other voluntary and formal act.

- 5. Persons upon whose training for the eccupation of teacher public money has been spent cannot be appointed until the consent of the appropriate education authority has been notified to the Civil Service Commissioners.
- 6. The Examination will be in the following subjects, viz.:—
 - (1) English.
 - (2) Arithmetic.
 - (3) Either French or Geography.

No candidate will be regarded as qualified who does not pass to the satisfaction of the Civil Service Commissioners in English and in the aggregate of the marks for the whole Examination.

- 7. Application for permission to attend the Examination must be made at such time and in such manner as may be fixed by the Civil Service Commissioners; the application must be accompanied by a certificate from the authorities of the Department in which the candidate is serving, in the space provided on the application form, that she satisfies the conditions laid down in Clause 1 of these regulations, that she is competent to perform the duties of an established Typist or Clerk-Typist, and that in the event of her success the Department is prepared to accept her as an established member of the Typing grades.
