TENDERS FOR TREASURY BILLS.

1. The Lords Commissioners of His Majesty's Treasury hereby give notice that Tenders will be received at the Bill Office, at the Bank of England, on Friday the 7th July 1939, at 1 o'clock, for Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, and the War Loan Acts, 1914 to 1919, to the amount of £40,000,000.

2. The Bills will be in amounts of £5000 or £10,000. They will be dated at the option of the Tenderer on any business day from

Monday the 10th July 1939 to Saturday the 15th July 1939 inclusive, and will be payable at three months after date.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000, and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House, or Broker.

6. The persons whose Tenders are accepted will be informed of the same not later than the following day, and payment in full of the amounts of the accepted Tenders must be made to the Bank of England by means of Cash or a Banker's Draft on the Bank of England not later than 2 o'clock (Saturday 12 o'clock) on the day on which the relative Bills are to be dated.

7. In virtue of the provisions of Section 1 (4) of the War Loan Act, 1919, Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.

9. The Lords Commissioners of His Majesty's Treasury reserve the right of rejecting any Tenders.

The Civil Service Commissioners hereby give notice that the following Regulations are published with the approval of the Lords Commissioners of His Majesty's Treasury, viz. :—

REGULATIONS RESPECTING COMPETITIVE EXAMINATIONS FOR APPOINTMENT TO THE CONSULAR SERVICE, AND TO POSTS IN THE ASSISTANT OFFICER GRADE IN THE DEPARTMENT OF OVERSEAS TRADE AND IN THE EXPORT CREDITS GUARANTEE DEPARTMENT.

1. Candidates will be required to appear before a Board of Selection which will meet at the Office of the Civil Service Commission on the second Tuesday in May, and will decide which candidates possess suitable qualifications for entry into the Consular Service, and to posts in the Assistant Officer Grade in the Department of Overseas Trade and in the Export Credits Guarantee Department in order to enable them to compete at the Examination prescribed below. Candidates may appear before this Board at any time after they have attained the age of nineteen; but a candidate who is not recommended for acceptance by the Board of Selection may not appear before that Board for interview a second time unless he is specifically notified after his first appearance that the Board will be prepared to see him again.

2.—(i.) Candidates must have attained the age of 21 and must not have attained the age of 25 on the first day of August in the year in which the examination is held.

(ii.) Candidates for appointment to the Consular Service must be unmarried. Probationer vice-consuls who marry either during the first two years of their service or before passing the examinations prescribed for them will be refused confirmation of their appointment and will be required to forfeit the amount of their bonds.

3. Candidates for the Consular Service or the Assistant Officer Grade in the Department of Overseas Trade must be natural-born British subjects and born within the United Kingdom or in one of the self-governing Dominions of parents also born within those territories, except when the circumstances are such as to justify a departure from the general rule, in which case they can be allowed to compete by special permission of the Secretary of State for Foreign Affairs, provided they fulfil the conditions of the rule in respect of nationality prescribed for candidates for admission to His Majesty's Civil Service as a whole, viz. :—

“ Every candidate must be a natural-born British subject, the child of a person who is or was at the time of death a British subject. Provided that exception may be made in the case of natural-born British subjects who have satisfactorily completed a period of not less than five years' service on full pay in His Majesty's Regular Forces.

Provided also that if the Civil Service Commissioners are satisfied, in the case of any candidate who is a British subject but does not fulfil all the requirements of the rule as to nationality and descent, that the candidate is so closely connected by ancestry and upbringing with His Majesty's dominions that an exception may properly be made to that

rule, they may accept such candidate as eligible provided that this discretion shall not be exercisable unless (a) the father or the paternal grandfather of the candidate was a natural-born British subject, and (b) neither the father nor the paternal grandfather had acquired any other nationality by naturalization or by any other voluntary and formal act."

Candidates for the Assistant Officer Grade in the Export Credits Guarantee Department must fulfil the conditions of the above-mentioned rule prescribed for candidates for admission to His Majesty's Civil Service as a whole.

4. No person actually serving in the Army, Navy, or Air Force will be eligible for admission to the examination unless he produces to the Civil Service Commissioners when called upon to do so the permission of his Commanding Officer to attend the examination, dated before the commencement of the competition, and given in accordance with such orders as may from time to time be issued.

Persons holding situations in the Civil Service must obtain the permission of the authorities of their Department to attend the Examination before the commencement of the competition.

Persons upon whose training for the occupation of teacher public money has been spent cannot be appointed until the consent of the appropriate education authority has been notified to the Civil Service Commissioners.

5. Candidates must satisfy the Civil Service Commissioners as to their health and character.

7. Candidates must take up subject 68 French Language, and reach a high standard in it. They must also take either subject 27 General Economics, or subject 3 Elementary Economics, but they may not take both.

8. In Section B a candidate who wishes to offer subjects the aggregate value of which ex-

ceeds 750 marks (or 800 marks if Russian Language be selected) must name a subject to be valued on a reduced maximum in order to bring the aggregate to 750 (or 800). This option cannot be exercised by a candidate who can make the reduction by omitting one or more of the subjects he proposes to offer.

9. The following restrictions apply to particular subjects in Section B.

International Relations (26) may not be taken by a candidate who offers European History, Period 3 (9), or International Law (15).

Greek Literature (61) may be taken only by candidates who offer Greek Translation (58), and Latin Literature (65) only by those who offer Latin Translation (62).

In subjects 69 to 85 the history or literature paper associated with a language may be taken only by candidates who offer the language itself for examination.

A candidate who offers one or more of the subjects French History (69), German History (72), Spanish or Italian History (75), Russian History (78), may not offer either subject 8 (European History, Period 1 or Period 2), or subject 9 (European History, Period 3).

10. A candidate desiring to offer Experimental Psychology (23), or any of the subjects 38 to 49 must produce evidence satisfactory to the Civil Service Commissioners of laboratory training in an institution of university rank. For Astronomy (37), Engineering (50), Geography (51), and the Physical Anthropology branch of Special Anthropology (53), other equivalent training will be required. There will be no laboratory test as part of the examination.

11. From the marks assigned to candidates in each subject such deduction will be made as the Civil Service Commissioners may deem necessary in order to secure that no credit be allowed for merely superficial knowledge.

12. Moreover, candidates whose handwriting is not easily legible will suffer a further deduction of marks on that account.

13. Application for permission to attend one of these examinations must be made in the writing of the candidate, at such times and in such manner as may be fixed by the Commissioners.

14. A fee of £2 will be required from every applicant for permission to attend an examination; this fee is not returnable in any circumstances. A further fee of £6, being the balance of the prescribed fee of £8, will be required from every candidate attending such examination.

REGULATIONS GOVERNING THE APPOINTMENT OF JUNIOR ACCOUNTANTS IN THE INLAND REVENUE DEPARTMENT.

N.B.—*Competitions under these Regulations are open both to men and women. The*

Regulations are liable to alteration from time to time.

1. The Civil Service Commissioners will satisfy themselves that the steps taken by the Department by public advertisement in the Press or otherwise to make known the existence of vacancies have been such as to secure all desirable publicity. The advertisement will fix the last day on which applications can be received and the date by which the age limits will be reckoned.

2. Applications will be addressed to the Department on the appropriate form. After the last day for application has been reached, the authorities of the Department will scrutinize all the applications received and recommend to the Commissioners such candidates as appear to them to be best qualified for the duties. They will at the same time forward to the Civil Service Commissioners the application forms of the candidates recommended, together with the forms of any candidates not recommended who are employed in a Government Department; and the list of candidates to be interviewed by the Selection Board will then be settled by agreement between the Department and the Civil Service Commissioners, who may, if dissatisfied with the candidates recommended, take such steps in consultation with the Department as they think fit to obtain other candidates.

3. Candidates recommended by the Department and accepted by the Civil Service Commissioners as possessing the requisite qualifications will be summoned to an interview before a Selection Board, who will select for the vacancies existing those candidates who appear to them to possess the qualifications most suited to the positions to be filled. The Selection Board will usually comprise representatives of the Civil Service Commission, the Department, and a nominee of the Institute of Chartered Accountants in England and Wales.

4. Candidates must be under the age of 30 on a date to be fixed in respect of the competition in which they are to take part. Candidates who have served or are serving in the Navy, Army, or Air Force may deduct from their actual age any time during which they have so served.

5. Candidates must possess the following qualifications :—

(a) they must have passed the final examination of the Institute of Chartered Accountants in England and Wales or the corresponding examination of the Society of Incorporated Accountants and Auditors, the Society of Accountants, Edinburgh, the Institute of Accountants and Actuaries, Glasgow, the Society of Accountants, Aberdeen, or the Institute of Chartered Accountants, Ireland;

(b) they must have had not less than two years' professional experience in the office of a qualified professional Accountant which in the opinion of the Civil Service Commissioners and of the Department gives an adequate range of experience, in addition to the period of Articles.

Women candidates must be unmarried or widows and will normally be required to resign their appointments on marriage; but exception

to the rule requiring resignation on marriage may, in individual circumstances, be made where the employment of a married woman is considered advisable in the light of her special qualifications, or special experience in relation to the duties required of her, or of the special requirements of the Department.

6. Every candidate must be a natural-born British subject, the child of a person who is or was at the time of death a British subject; provided that exception may be made in the case of natural-born British subjects who have satisfactorily completed a period of not less than five years' service on full pay in His Majesty's Regular Forces.

Provided also that if the Civil Service Commissioners are satisfied, in the case of any candidate who is a British subject but does not fulfil all the requirements of the rule as to nationality and descent, that the candidate is so closely connected by ancestry and upbringing with His Majesty's dominions that an exception may properly be made to that rule, they may accept such candidate as eligible provided that this discretion shall not be exercisable unless (a) the father or the paternal grandfather of the candidate was a natural-born British subject, and (b) neither the father nor the paternal grandfather had acquired any other nationality by naturalization or by any other voluntary and formal act.

7. The appointment of selected candidates will be subject to their satisfying the Civil Service Commissioners of their eligibility in respect of age, nationality, health, and character and will not be confirmed unless and until they have passed the prescribed period of probation to the satisfaction of the Department. Appointments will be subject to the condition that the person appointed may be required to serve in any town in Great Britain and Northern Ireland, and will be engaged in work that may necessitate a certain amount of travelling.

Accountants in the service of the Board are not allowed to participate in any professional practice or to accept any fees or reward for professional or official services. This regulation is not intended to extend to an appointment of an honorary nature (e.g. Auditor to a Provident Fund). The Board's authority to hold such an appointment must, however, first be obtained.

8. Persons holding situations in the Civil Service must obtain the permission of the authorities of their Department to apply for appointment.

No person actually serving in the Navy, Army, or Air Force will be eligible for consideration unless he produces when called upon to do so the permission of his Commanding Officer to apply for appointment, dated before his appearance before the Selection Board and given in accordance with such orders as may from time to time be issued.

Persons upon whose training for the occupation of teacher public money has been spent cannot be appointed until the consent of the appropriate Education Authority has been notified to the Civil Service Commissioners.

9. Any attempt on the part of candidates to enlist support for their applications through

Members of Parliament or other influential persons will disqualify them for appointment. The Selection Board will disregard spontaneous recommendations from persons who are not personally acquainted with the candidate's work.

10. Candidates selected for appointment will be required to pay a fee of £8.
