SAFEGUARDING OF INDUSTRIES ACT, 1921.

Amendment of List of Articles Chargeable with Duty under Part I.

(Safeguarding of Key Industries.)

- 1. Section 1 (5) of the Safeguarding of Industries Act, 1921, provides that for the purpose of preventing disputes arising as to whether any goods are or are not chargeable with duty under Part I. of the Act, the Board of Trade may from time to time issue lists defining the articles which are to be taken as falling under any of the general descriptions set out in the Schedule to the Act, and where any list is so issued defining the articles which are to be taken as falling under such general description, the said Schedule shall have effect as if the articles comprised in the lists were therein substituted for that general description.
- 2. Section 5 (3) of the Finance Act, 1936, provides, amongst other things, that the power of the Board of Trade under sub-section (5) of Section 1 of the Safeguarding of Industries Act, 1921, to issue lists defining articles which are to be taken as falling under any of the general descriptions set out in the Schedule to that Act shall include power to amend any list so issued.
- 3. The Board of Trade hereby amend List H issued in 1921 by deleting mercury chloride and substituting mercury subchloride.

> Civil Service Commission, July 4, 1939.

The Civil Service Commissioners hereby give notice that the following Regulations are published with the approval of the Lords Commissioners of His Majesty's Treasury, viz.:—

Special Regulations for the Recruitment by Competitive Selection of Cartographers (Unestablished) in the Hydrographic Department of the Admiralty.

- N.B.—Competitions under these regulations are open both to men and women. The regulations are liable to alteration from time to time.
- 1. Candidates should be under 25 years of age on the last day fixed for the receipt of applications, but consideration will be given to those with special qualifications up to the age of 30 years.
- 2. Every candidate must be a natural-born British subject, the child of a person who is or was at the time of death a British subject; provided that exception may be made in the case of natural-born British subjects who have satisfactorily completed a period of not less

than five years' service on full pay in His Majesty's Regular Forces.

Provided also that if the Civil Service Commissioners are satisfied, in the case of any candidate who is a British subject but does not fulfil all the requirements of the rule as to nationality and descent, that the candidate is so closely connected by ancestry and upbringing with His Majesty's dominions that an exception may properly be made to that rule, they may accept such candidate as eligible provided that this discretion shall not be exercisable unless (a) the father or the paternal grandfather of the candidate was a natural-born British subject, and (b) neither the father nor the paternal grandfather had acquired any other nationality by naturalisation or by any other voluntary and formal act.

The consent of the authorities of the Admiralty is required before the child of a naturalised British subject can be appointed to that Department.

3. Persons holding situations in the Civil Service must obtain the permission of the authorities of their Department to apply for appointment.

No person actually serving in the Navy, Army, or Air Force will be eligible for consideration unless he produces, when called upon to do so, the permission of his Commanding Officer to apply for appointment, dated before his appearance before the Selection Board, and given in accordance with such orders as may from time to time be issued.

Persons upon whose training for the occupation of teacher public money has been spent, cannot be appointed until the consent of the appropriate education authority has been notified to the Civil Service Commissioners.

- 4. Applications for admission to a competition for these appointments must be made at such time and in such manner as the Civil Service Commissioners may appoint; an application cannot be recorded until a competition has been announced.
- 5. The Civil Service Commissioners will take such steps as they think most appropriate to make known the existence of any vacancies which it may be desired to fill on any one occasion.
- 6. Candidates should have followed a full course at an institution of University rank, and have passed the examination qualifying for a degree, or its equivalent, preferably in geography; but similar qualifications in mathematics, physics, or engineering will be considered. Candidates must possess a knowledge of the principal map and chart projections, of the methods and principles of surveying, and of physical geography, and should be accurate, though not necessarily highly-finished, draughtsmen. Experience of field surveying and knowledge of a modern language will be additional recommendations.
- 7. When the list of applications in respect of a competition has been closed, the credentials of all the candidates will be examined by the Civil Service Commissioners, who may, if they so desire, invite the assistance of officers of the Admiralty; and those candidates who appear to have the requisite qualifications and to be best

fitted for appointment will be summoned to an interview before a Selection Board, who will recommend for the vacancies existing those candidates who appear to them to possess the highest qualifications. The decision of the Selection Board will be final. The Board will be constituted by the Civil Service Commissioners in consultation with the authorities of the Admiralty, who will be represented on the Roard.

- 8. Female candidates must be unmarried or widows and will be required to resign their appointments on marriage.
- 9. Candidates may submit with their application for admission to the competition reports or recommendations on their experience or qualifications from previous employers or the authorities at the colleges or schools at which they have been trained.

Any attempt, direct or indirect, on the part of candidates to enlist support for their applications through persons other than those mentioned in the previous paragraph will disqualify them for appointment.

10. The necessary number of candidates will be appointed in a temporary capacity, subject to their satisfying the Civil Service Commissioners that they are eligible in respect of age, nationality, health, and character, and to the payment of a fee of £3. They will be eligible for subsequent appointment to the established grade of Cartographer as vacancies occur therein. Appointment to the established staff is conditional on the issue by the Civil Service Commissioners of a certificate of qualification; a fee of £3, being the balance of the prescribed fee of £6, is payable before the certificate of qualification can be issued.

The Civil Service Commissioners further give notice of a competition to be held under the foregoing Regulations.

The number of appointments to be made on the result of this competition will be not less than 3, provided so many candidates are recommended by the Selection Board as fully qualified.

No person will be considered from whom the Secretary of the Civil Service Commission has not received, on or before the 27th July 1939, an application in the candidate's own handwriting, on a prescribed form, which may be obtained from the Secretary at once.

The date on which the Selection Board will meet (probably early in September 1939) will be decided later.
