**ARCHITECTS (REGISTRATION) ACT,  
1931.**

A Regulation made by the Architects Registration Council of the United Kingdom under Section 13 of the above-mentioned Act has been submitted for the approval of the Privy Council and is published herewith.

**REGULATION MADE IN PURSUANCE OF SECTION 13  
OF THE ARCHITECTS (REGISTRATION) ACT,  
1931, AMENDING THE EXISTING REGULATIONS.**

*Amendment to Regulation 26.*

Add the following paragraph at the end of the Regulation:—

“ or (5) if his application for registration be made before August 1st, 1940, and if having served before August 1, 1938, as an architectural assistant in an architect’s office in the

United Kingdom for a period of not less than one year, he proves to the satisfaction of the Admission Committee that on August 1st, 1938, he was an architectural assistant and that he had been engaged in the study of architecture and execution of architectural work in any part of His Majesty’s Dominions for at least seven years, and had received an architectural education and training equivalent in value to that normally received by an architect in the United Kingdom.”

*Amendment to Regulation 44.*

Before the words “ The Clerk ” insert “ (a). ”

At the end of 44 (1) insert the following paragraph:—

“ (b) For the purpose of the preparation of the Voters’ List, the bodies referred to in sub-paragraphs (i.) to (vi.) of paragraph 1 of the First Schedule of the Principal Act shall provide the Clerk, if so requested by him, not later than seven days after the said 31st day of October, with lists of their members corrected to the said 31st day of October; and in the event of such list of members not being received from any one of the said bodies by the date aforesaid, the Clerk shall use for the purpose the last published list of such body.”

#### TENDERS FOR TREASURY BILLS.

1. 5. Tenders must be made through a London Banker, Discount House, or Broker.

6. The persons whose Tenders are accepted will be informed of the same not later than the following day, and payment in full of the amounts of the accepted Tenders must be made to the Bank of England by means of Cash or a Banker's Draft on the Bank of England not later than 2 o'clock (Saturday 12 o'clock) on the day on which the relative Bills are to be dated.

7. In virtue of the provisions of Section 1 (4) of the War Loan Act, 1919, Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.
