TATHEREAS the Department of Health for Scotland have, in pursuance of the powers competent to them under the Burial Grounds (Scotland) Act, 1855, made a Representation that they have received a copy of an Interlocutor, dated 30th March 1939, pronounced by the Sheriff-Substitute of Perth and Angus, at Forfar, finding that the Burial Ground known as the Old Churchyard at Newtyle, in the Parish of Newtyle and County of Angus, is so crowded as to be dangerous to health or offensive or contrary to decency:

And whereas in the said Representation it is recommended that Burials be forthwith discontinued in the said Burial Ground in terms of Section 5 of the aforesaid Act, except for the reservation of the right of burial in the cases

hereinafter specified:

And whereas by an Order in Council of the 25th day of May 1939 Notice of such Representation was given and it was ordered that the same should be taken into consideration by a Committee of the Privy Council on the 10th day of July next and that the said Order, or Notice thereof, should be published in the Edinburgh Gazette, and that copies of the said Order or Notice thereof should be fixed on the doors or the Church of, or on some other conspicuous places within, the Parish of Newtyle one month before the said 10th day of July:
And whereas Notice of the said Representa-

tion and of the time when the same was ordered to be taken into consideration by the Privy Council has been duly published in the Edinburgh Gazette, and fixed in manner required by the said Order in Council:

Now, therefore, His Majesty, by and with the advice of His Privy Council, is pleased to order, and it is hereby ordered, as follows,

That burials be forthwith discontinued, in terms of Section 5 of the Burial Grounds (Scotland) Act, 1855, in the Burial Ground known as the Old Churchyard at Newtyle in the Parish of Newtyle and County of Angus, except for the reservation of the right of burial in the said burial ground of-

Belmont Street, Newtyle; (10) Miss Isabella Dingwall, Auchterneed, Newtyle;

(13) Persons whom the County Council of the County of Angus may specially authorise to be buried therein; and

(14) Cremated human remains.

Provided the exercise of the right of burial be not injurious to health or offensive or contrary to decency, that notice be given to the District Sanitary Inspector not later than the day preceding that on which a grave is to be opened and that no burial except the burial of cremated human remains shall be made unless the coffin can be laid at a depth of four feet from the surface of the ground to the upper surface of the coffin and that without interference with the remains of a previous burial.

MERCHANDISE MARKS ACT, 1926.

REFERENCE TO THE STANDING COMMITTEE.

In accordance with the provisions of subsection (4) of Section 2 of the Merchandise Marks Act, 1926, the Board of Trade give notice that in pursuance of an application received by them for the making of an Order in Council to require imported goods of certain classes and descriptions to bear an indication of origin they have made a reference to the Standing Committee appointed by them under the Act in respect of imported "Swords and Cutlasses and Blades thereof."

Attention is called to the fact that while, under the provisions of the above Act, the Committee must in every case referred to them

consider whether the goods should bear an indication of origin at the time of sale or exposure for sale, they may also at their discretion consider and report upon the question whether such goods should bear an indication of origin at the time of importation.

The Civil Service Commissioners hereby give notice that the following Regulations are published with the approval of the Lords Commissioners of His Majesty's Treasury, viz.:-

SPECIAL REGULATIONS RESPECTING AN OPEN COMPETITIVE EXAMINATION FOR THE SITUA-TION OF DRAUGHTSMAN (UNESTABLISHED) IN THE HYDROGRAPHIC DEPARTMENT OF THE ADMIRALTY.

N.B.—A Competition under these Regulations is open to candidates of either sex.

1. The limits of age for this situation are 18 and 30; candidates must be of the prescribed age on the first day of the examination. A candidate who attained the age of 18 on the first day of the examination would be admitted, but a candidate who attained the age of 30 on that day would not be admitted.

In reckoning age for competition the following allowances will be made:-

- (i.) Persons who have served or are serving in the Army, Navy, or Air Force may deduct from their actual age any time during which they have so served.
- (ii.) Persons who have served in any established civil situation to which they were admitted with the certificate of the Civil Service Commissioners may deduct from their actual age any time not exceeding two years which they may have spent in such service.
- 2. Every candidate must be a natural-born British subject, the child of a person who is or was at the time of death a British subject; provided that exception may be made in the case of natural-born British subjects who have satisfactorily completed a period of not less than five years' service on full pay in His Majesty's Regular Forces.

Provided also that if the Civil Service Commissioners are satisfied, in the case of any candidate who is a British subject but does not fulfil all the requirements of the rule as to nationality and descent, that the candidate is so closely connected by ancestry and upbringing with His Majesty's dominions that an exception may properly be made to that rule, they may accept such candidate as eligible provided that this discretion shall not be exercisable unless (a) the father or the paternal grandfather of the candidate was a natural-born British subject, and (b) neither the father nor the paternal grandfather had acquired any other nationality by naturalization or by any other voluntary and formal act.

The consent of the authorities of the Admiralty is required before the child of a

naturalized British subject can be appointed to that Department.

3. No person actually serving in the Army, Navy, or Air Force will be eligible for admission to the examination unless he produces to the Civil Service Commissioners, when called upon to do so, the permission of his Commanding Officer to attend the examination, dated before the commencement of the competition, and given in accordance with such orders as may from time to time be issued.

Persons upon whose training for the occupation of teacher public money has been spent cannot be appointed until the consent of the appropriate education authority has been notified to the Civil Service Commissioners.

Persons holding situations in the Civil Service must obtain the permission of the authorities of their Department to attend the examination before the commencement of the competition.

- 4. Candidates must satisfy the Civil Service Commissioners as to their health and character. Female candidates must be unmarried or widows and will be required to resign their appointments on marriage.
- 5. The examination will be in the following subjects, viz.:—
  - 1. Drawing.
  - 2. English.
  - 3. Arithmetic.
  - 4. Geography.
  - 5. Mathematics.

Candidates must satisfy the Civil Service Commissioners in drawing and in the aggregate. A high standard of draughtsmanship is required.

- 6. Application for permission to attend an examination must be made in the writing of the candidate, at such time and in such manner as may be fixed by the Civil Service Commissioners.
- 7. A fee of 15s. will be required from each candidate attending the examination.
- 8. The successful candidates will be appointed in a temporary and unestablished capacity, subject to their satisfying the Civil Service Commissioners that they are eligible in respect of age, nationality, health, and character; they will be eligible for subsequent appointment to the established grade of Draughtsman as vacancies occur therein. Appointment to the established staff is conditional on the issue by the Civil Service Commissioners of a certificate of qualification; a fee of 15s., being the balance of the prescribed fee of £1 10s., is payable before the certificate of qualification can be issued.

The Civil Service Commissioners further give notice that an Open Competitive Examination will be held under the foregoing Regu-

lations, commencing on the 24th October 1939. The following is a provisional list of the centres at which the examination may be held:—Cardiff, Glasgow, London, and Newcastle-on-Tyne; the final list of centres will be decided when the number of candidates desiring examination at each centre is known.

Not fewer than 14 candidates will be appointed on the result of this examination, if so many should be found to be duly qualified.

No person will be admitted to examination from whom the Secretary of the Civil Service Commission has not received, on or before the 7th September 1939, an application in the candidate's own handwriting on a prescribed form, which may be obtained from the Secretary at once.
