ACT OF ADJOURNAL.

RELATIVE TO PROCEDURE IN CRIMINAL TRIALS UNDER SECTION 3 OF THE ADMINISTRATION OF JUSTICE (EMERGENCY PROVISIONS) (SCOTLAND) ACT, 1939, HEREINAFTER REFERRED TO AS "THE ACT."

At Edinburgh, the eleventh day of September nineteen hundred and thirty-nine.

The Lord Justice-General, Lord Justice-Clerk, and Lords Commissioners of Justiciary, by virtue of the powers conferred upon the Court by an Act passed in the Third Session of the Second Parliament of King Charles the Second entituled "Act concerning the Regula-"tion of Judicatories" and "The Criminal Procedure (Scotland) Act, 1887," 50 & 51 Vict., c. 35,

· Do hereby ENACT and DECLARE that from and after the passing hereof the following provisions shall have effect, viz.:—

I. Any Application made by or on behalf of the Lord Advocate or by or on behalf of the Accused under Section 3 (1) of the Act, to direct that the provisions therein should not apply by reason of the gravity of the matters in issue, may be made to the Clerk of Justiciary, 2 Parliament Square, Edinburgh, by letter or telegram addressed to said Clerk.

II. On receipt of such Application the Clerk shall forthwith submit it and a copy of the Indictment in the case to a Court of not less than three Judges of the High Court of Justiciary who may dispose of the Application in Chambers or otherwise. On judgment being delivered by the Court the Clerk shall endorse the finding of the Court on the Record Copy of the Indictment. Thereafter at the trial of the cause a copy of the endorsement shall be entered in the Record of the proceedings.

III. This Act of Adjournal shall come into operation on the date hereof, and shall be printed and published in the Edinburgh Gazette.

DEFENCE OF THE REALM.

THE CULTIVATION OF LANDS (SCOT-LAND) ORDER, DATED 4TH SEPTEMBER 1939, MADE BY THE SECRETARY OF STATE FOR SCOTLAND UNDER PART IV. AND PART V. OF THE DEFENCE REGULATIONS, 1939.

In pursuance of Regulations 49, 51, 53, 62, 63, 66 and 85 of The Defence Regulations, 1939, the Secretary of State for Scotland (hereinafter referred to as the Secretary of State) hereby makes the following Order:—

- 1. The body of persons who are for the time being appointed by the Secretary of State, as the Agricultural Executive Committee (hereinafter referred to as the Committee) for any area in Scotland, for the purpose of increasing or maintaining agricultural production, are hereby authorised in terms of Regulation 85 to grant authority to the members of the Committee, the officers of the Committee and persons (not being members of the Committee) whom it may appoint as members of Sub-Committees, for the purpose of the aforesaid regulations, to enter on and inspect any land or building within the area of the Committee.
- 2. The Secretary of State hereby delegates his powers under Regulations 51, 62 and 63 of the said Regulations in respect of any land in Scotland and under Regulation 53 in respect of any corporeal moveable required in connection with the use of such land to the appropriate Committee for each area in Scotland and such powers shall be exercised by the Committee at the expense of the Secretary of State subject to such directions as to approval of expenditure or otherwise as may from time to time be given to the Committee by the Secretary of State.

Provided that the Committee shall not without the consent of the Secretary of State in writing being previously given:

- (a) take possession of any land or terminate the tenancy of any land;
- (b) give directions with respect to the cultivation, management or use of any land that is kept or preserved mainly or ex-

- clusively for purposes of sport or recreation, or land used as a race-course, or
- (c) requisition any corporeal moveable except such corporeal moveable as may be found upon or may have been removed from any land of which the Committee are in possession.
- 3. The rights of any person dealing with the Committee shall not be prejudiced by the fact that the Committee have not complied with any direction given to them by the Secretary of State or have acted without the consent of the Secretary of State where such consent is required.
- 4. The Secretary of State may by order revoke any authority given or delegation made by this Order either generally or in relation to any particular Committee.
- 5. The following provision shall have effect with regard to Committees and their procedure:—
 - (1) The Chairman shall appoint one or more members of the Committee to act as Vice-Chairmen.
 - (2) The Committee may appoint Subcommittees for such purposes as the Committee think fit. A Sub-committee may consist either wholly or partly of persons not being members of the Committee.
 - (3) At any meeting at which the Chairman or a Vice-Chairman is not present a person shall be appointed by the meeting to act as Chairman. At any meeting of the Committee the Chairman shall, in case of an equal division of votes, have a second or casting vote.
 - (4) The quorum, proceedings and place of meeting of the Committee shall be such as the Committee determine.
 - (5) The proceedings of the Committee shall not be invalidated by any vacancy among its members or by any defect in the appointment of any of its members.
 - (6) A member of the Committee shall not vote on any question which relates to land of which he is the owner or occupier, or the agent or factor of the owner or occupier, or enter into any contract with the Committee unless such contract has been approved by the Secretary of State.
 - (7) Minutes of the proceedings of the Committee shall be kept in a book provided for that purpose, and a minute of those proceedings signed at the same or the next ensuing meeting by the Chairman of the meeting at which the minute is signed shall be received in evidence without further proof.
 - (8) Any notice, direction or other instrument signed by the Chairman or a Vice-Chairman or by the Secretary of the Committee shall be received in evidence without further proof as a notice, direction or instrument issued by the Committee.
 - (9) Accounts shall be kept by the Committee of their receipts and expenditure, and be open to inspection by any officer authorised by the Secretary of State and those accounts shall be made up and audited in such manner as the Secretary of State shall direct.

- (10) Until the contrary is proved, the Committee shall be deemed to have been duly constituted.
- 6. This Order may be cited as the Cultivation of Lands (Scotland) Order, 1939.

In pursuance of the powers conferred upon me by the Defence Regulations, 1939, I hereby make the following Order:—

Whereas it is provided by paragraph (1) of Regulation 17 of the Defence Regulations, 1939, that no person being either a British subject or a British Protected Person shall, without the permission of a Secretary of State or the Admiralty or of a person authorised by a Secretary of State or the Admiralty to grant permission for the purpose of this Regulation, voluntarily enter any enemy territory or voluntarily go aboard any vessel or aircraft being used in the service of a Power at war with His Majesty;

I do hereby direct that the permission of one of His Majesty's Superintending Consular Officers shall, in respect of any British subject or British Protected Person within the jurisdiction of such Consular Officer, be treated for the purpose of paragraph (1) of the said Regulation as if it were such permission as is mentioned in that paragraph.

TENDERS FOR TREASURY BILLS.

- 1. - 3. The Bills will be issued and paid at the Bank of England.
- 4. Each Tender must be for an amount not less than £50,000, and must specify the date on which the Bills required are to be dated,

- and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.
- 5. Tenders must be made through a London Banker, Discount House, or Broker.
- 6. The persons whose Tenders are accepted will be informed of the same not later than the following day, and payment in full of the amounts of the accepted Tenders must be made to the Bank of England by means of Cash or a Banker's Draft on the Bank of England not later than 2 o'clock (Saturday 12 o'clock) on the day on which the relative Bills are to be dated.
- 7. In virtue of the provisions of Section 1 (4) of the War Loan Act, 1919, Members of the House of Commons are not precluded from tendering for these Bills.
- 8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.
- 9. The Lords Commissioners of His Majesty's Treasury reserve the right of rejecting any Tenders.

GENERAL LICENCE.

TRADING WITH THE ENEMY.

FEES IN RESPECT OF PATENTS, DESIGNS AND TRADE MARKS.

The Board of Trade, in pursuance of the powers conferred upon them by Section 1 of the Trading with the Enemy Act, 1939, and of all other powers enabling them in that behalf, do hereby authorise—

- (1) the payment on behalf of any person not being an enemy of any fees necessary for obtaining the grant of or for obtaining the renewal of Patents, or for obtaining the registration of Designs or Trade Marks or the renewal of such registration, in enemy territory, and the payment to enemies of their charges and expenses in relation to the matters aforesaid;
- (2) the payment on behalf of an enemy of any fees payable on application for or renewal of the grant of Patents, or an application for the registration of Designs or Trade Marks or the renewal of such registration in any country not being enemy territory and the payment on behalf of an enemy to persons not being enemies of their charges and expenses, in relation to the matters aforesaid, and the receipt of payments from an enemy in relation to the matters aforesaid;

Provided always that any payment on behalf of an enemy under this paragraph, unless it is made by a person who has an interest in or under the patent, design or trade mark in question, may be made by the person making the same only out of moneys—

- (a) remitted by or on behalf of such enemy, or
- (b) held for or on account of such enemy, and not by way of gift or by way of advancement or loan to or on account of such enemy.

OPEN GENERAL EXPORT LICENCE No. G.L. 208.

Whereas by the Export of Goods (Prohibition) (No. 2) Order, 1939, the exportation of certain goods including the goods hereinafter mentioned was prohibited unless the exportation of the said goods is authorised by a licence of the Board of Trade.

Now therefore the Board of Trade do hereby authorise and permit the exportation of tobacco from any port in the United Kingdom subject to the following conditions:—

- (1) That the owner or shipper of the said goods, if so required by the Commissioners of His Majesty's Customs and Excise, shall produce to them, within such time as they may allow, proof to their satisfaction that the said goods were duly delivered to the destination stated in the shipping documents;
- (2) This licence may be modified or revoked at any time by the Board of Trade, without reason given.

This licence shall come into force on the 11th September 1939.
