(HERBERT CECIL DUCKWORTH.)

And whereas I am of opinion that the said Herbert Cecil Duckworth cannot properly be allowed for the purposes of the Raw Opium, &c., Regulations, 1937, and the Dangerous Drugs Regulations, 1937, to remain an authorised person or to give prescriptions:

Now therefore I hereby cancel, as from to-day's date, the Notice of suspension published in the London Gazette and Edinburgh Gazette on the 14th April 1939.
