TENDERS FOR TREASURY BILLS.

- 1. The Lords Commissioners of His Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England, on Friday the 16th February 1940, at 1 p.m., for Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, and the National Loans Act, 1939, to the amount of £65,000,000.
- 2. The Bills will be in amounts of £5000, £10,000, £50,000, or £100,000. They will be dated at the option of the Tenderer on any business day from Monday the 19th February 1940 to Saturday the 24th February 1940 inclusive, and will be payable at three months after date.
- 3. The Bills will be issued and paid at the Bank of England.
- 4. Each Tender must be for an amount not less than £50,000, and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.
 - 5. Tenders must be made through a London Banker, Discount House, or Broker.

- 6. The persons whose Tenders are accepted will be informed of the same not later than the following day, and payment in full of the amounts of the accepted Tenders must be made to the Bank of England by means of Cash or a Banker's Draft on the Bank of England not later than 1.30 p.m. (Saturday, 12 noon) on the day on which the relative Bills are to be dated.
- 7. Members of the House of Commons are not precluded from tendering for these Bills.
- 8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.
- 9. The Lords Commissioners of His Majesty's Treasury reserve the right of rejecting any Tenders.

(Application for Special Order under the Gas Undertakings Acts, 1920 to 1934).

NOTICE is hereby given that application is intended to be made to the Board of Trade forthwith by the Buckhaven and Leven Gas Commissioners (hereinafter referred to as "the Commissioners"), whose address is North Street, Leven, for a Special Order under the Gas Undertakings Acts, 1920 to 1934, for all or some of the following (amongst other) purposes (that is to say):—

To extend the existing limits of gas supply of the Commissioners and to authorise them to supply gas within the following parts of the Parishes of Wemyss and Scoonie in the County of Fife:—

So much of the Parish of Wemyss as is situated within an imaginary line commencing at low water mark on the western boundary of the Burgh of Buckhaven and Methil, thence proceeding along low water mark in a south-westerly direction for a distance of 2221 yards or thereby, thence proceeding in a straight line in a northwesterly direction to the western side of the mineral railway from Michael Colliery, thence proceeding in northerly, northeasterly, and northerly directions for a distance of 1860 yards or thereby along the western side of the said mineral railway to the northern side of East Newton Farm road, thence proceeding in a north-easterly direction along the northern side of the said farm road until it crosses the mineral railway from Wellsgreen Colliery to Methil Brick Works, thence proceeding in easterly and northeasterly directions along the northern side of the last-mentioned mineral railway until it meets the mineral railway from Isabella Colliery, thence proceeding in a northeasterly direction along the northern side of the said mineral railway to the western boundary of the Burgh of Buckhaven and Methil, thence proceeding in southerly, south-easterly, south-westerly, southwesterly, south-easterly and southerly directions along the boundary of the said burgh to the point of commencement.

So much of the Parishes of Wemyss and Scoonie as is situated within an imaginary line commencing at a point on the northern boundary of the Burgh of Buckhaven and Methil 132 yards or thereby west of the centre of the road from Crossroads to Kirkland, thence proceeding in a northerly direction for a distance of 153 yards or thereby to the south side of Kirkland Mill Lade, thence proceeding in westerly and northwesterly directions along the south and west sides of the said mill lade for a distance of 205 yards or thereby, thence proceeding in a northerly direction for a distance of 162 yards or thereby to a point on the northern boundary of the East of Fife section of the London and North Eastern Railway, thence proceeding along the northern boundary of the said railway in south-easterly, easterly, and north-easterly directions for a distance of 665 yards or thereby, thence proceeding in a northerly direction to the eastern boundary of Haugh House Farm road and along the western boundary of the road from the said farm to the southern side of the Leven-Windygates Road, thence proceeding along the said road in an easterly direction for a distance of 212 yards or thereby, thence proceeding in northerly and north-westerly directions across the said road along the eastern and northern boundaries of Banbeath Cottages, the eastern boundary of the road to Banbeath Farm steading, the eastern and northern boundaries of the said steading and the eastern side of the road to Cotton of Durie, thence proceeding in a northeasterly direction along the southern side of the road from Cotton of Durie to the Leven-Kennoway Road, crossing the said road and continuing along the southern side of Cock-my-Lane to the western boundary of the Burgh of Leven, thence proceeding in southerly, south-westerly, south-easterly, westerly, southerly and south-easterly directions along the boundary of the Burgh of Leven to the south-eastern corner of Leven Bridge, thence proceeding in a south-westerly direction along the south-eastern side of Leven Bridge to the boundary of the Burgh of Buckhaven and Methil, thence proceeding in north-westerly and westerly directions along the boundary of the said Burgh to the point of commencement.

So much of the Parish of Scoonie as is situated within an imaginary line commencing at the northmost point of the boundary of the Burgh of Leven, thence proceeding in a north-easterly direction for a distance of 285 yards or thereby along the western bank of the Scoonie Burn, thence proceeding in a northerly direction for a distance of 62 yards or thereby across and along the eastern boundary of the said burn, thence proceeding in a north-easterly direction for a distance of 46 yards or thereby along the southern boundary of the road from Coldstream and across the Leven to Cupar Road, thence proceeding in a north-easterly direction for a distance of 495 yards or thereby along the south side of the road to Blacketyside, thence proceeding in a south-easterly direction for a distance of 880 yards or thereby along the western boundary of the road to and passing Blacketyside and Blacketyside Cottages to the south side of the road from Leven to Lundin Links, thence proceeding in a southwesterly direction along the said side of the said road to the boundary of the Burgh of Leven, thence proceeding in south-westerly, northerly, westerly and northerly directions along the boundary of the said Burgh to the point of commencement.

To empower the Commissioners to erect, maintain, alter, improve and renew gasworks with all necessary machinery and apparatus and to make and store gas and to work up and convert residual products upon the lands hereinafter described and to purchase and use material required to work up and convert residual products.

The said lands are:-

That piece of land within the Burgh of Leven, Parish of Scoonie, and County of Fife, bounded on the North by Carlow Place, on the East by Brewery Wynd, on the South partly by North Street and partly by Bridge Street, and on the West by Riverside Place but excepting always therefrom:—

(FIRST) That piece of ground containing 132 decimal or one thousandth parts of an acre or thereby, situated in the said Burgh, Parish and County, belonging or reputed to belong to James Neaves, bounded on the South by Bridge Street and on the West, North, and East by property belonging to the Commissioners.

(SECOND) That piece of ground containing 86 decimal or one thousandth parts of an acre or thereby, situated in the said Burgh, Parish and County, belonging or reputed to belong to George Russell, bounded on the South by Bridge Street and on the West, North, and East by property belonging to the Commissioners; and

(THIRD) That piece of ground containing 290 decimal or one thousandth parts of an acre or thereby, situated in the said Burgh, Parish and County, belonging or reputed to belong partly to Alexander Robertson and partly to Star Hotel (Leven), Limited, bounded on the South by Bridge Street and North Street, on the West partly by Bridge Street and partly by property belonging to the Commissioners, and on the North and East by property belonging to the Commissioners.

The area of the piece of land under description but excluding as aforesaid, is 4 acres and 254 decimal or thousandth parts of an acre or thereby.

To provide that subject to the provisions of the Order the Commissioners shall have and may exercise within the added limits or any part or parts thereof all powers, rights, privileges and authorities which they have within their existing limits of gas supply.

Powers and provisions as to:—Breaking up streets on boundary of limits of supply; supply of gas fittings, &c.; provision of showrooms, offices, exhibitions and demonstrations in connection with gas undertaking; dwelling-houses and other buildings in connection with gas undertaking and other powers usually conferred on gas undertakers.

To provide that the Chairman of the Commissioners, or in his absence one of the Commissioners, shall preside at meetings of the Commissioners and whilst so presiding shall have both a deliberate and, in case of equality, a casting vote.

To incorporate with the Order, with or without modification, all or some of the provisions of the Lands Clauses Acts, the Gasworks Clauses Act, 1847 and the Gasworks Clauses Act, 1871 and to repeal, alter, extend, or amend, or to make applicable to the objects

and purposes of the Order, the provisions or some of the provisions of the Burghs Gas Supply (Scotland) Acts, 1876 to 1918, the Buckhaven and Leven Gas Commission Order, 1922, and any other Act or Order relating to the Commissioners or their undertaking.

Imposition, recovery, and application of penalties and other sums due to the Commissioners.

The Order will vary or extinguish all rights and privileges which would impede or interfere with its purposes, and confer other rights and privileges.

Any local or other public authority, company, or person desiring to bring before the Board of Trade any objection to the Draft Order may do so by registered letter addressed to the Director of Gas Administration, Board of Trade, Great George Street, London, S.W.1, and despatched on or before the 18th day of March 1940.

Any such objection shall state:-

- (a) The specific grounds of objection, and
- (b) The omissions, additions or modifications asked for.

A copy of the objection must, at the same time, be forwarded to the undermentioned Solicitors or Parliamentary Agents.
