The Treasury hereby give notice that they propose to make an Order under Section 20 of the Finance (No. 2) Act, 1940, dealing with certain drugs. The goods proposed to be dealt with are the drugs specified in the list set out in the Treasury Notice of the 17th September last as being essential drugs of an exceptionally costly character, and certain drugs and simple preparations added to that list pursuant to representations made in response to that Notice. It is proposed to give such directions as will secure that any of those goods which may not fall within the existing exemption shall cease to be chargeable with purchase tax and that the tax shall become chargeable at the reduced rate on any other drugs or preparations which may fall within the existing exemption.
