Under the Special Enactments (Extension of Time) Act, 1940, the Secretary of State has made an Order extending by three years from the 19th December 1940 the time limited by Section 7 of the Fraserburgh Harbour Order, 1930, during which the Harbour Commissioners may raise by not exceeding two third parts the rates authorised by Schedule A (Rates for Vessels) and Schedule B (Rates for Goods) of the Fraserburgh Harbour Order, 1891, as amended by Section 4 of the Fraserburgh Harbour (Rates) Order, 1919.
