

#### THE SHORT BROTHERS (ROCHESTER & BEDFORD) LIMITED (TRANSFER OF SHARES) ORDER, 1943, MADE UNDER REGULATION 78 OF THE DEFENCE (GENERAL) REGULATIONS, 1939.

(GENERAL) RECOLLETIONS, 1958. (c) The ordinary share with the next lowest number is



transferred to Mr. Reginald Halsall of the Ministry of Aircraft Production, Millbank, London, S.W.1, (d) The remainder of the ordinary shares and all the "A" ordinary shares and all the 5 per cent. Redeemable Cumulative Preference Shares are transferred to the Solicitor for the Affairs of His Majesty's Treasury, of Storey's Gate, St. James's Park, London, S.W.1.

2. The date of transfer for the purposes of paragraph (4) (a) of Regulation 78 of the Defence (General) Regulations, 1939, shall be the twenty-third day of March 1943. 3. This Order shall come into force on the twenty-third day of March 1943, and may be cited as the Short Brothers (Rochester & Bedford) Limited (Transfer of Shares) Order, Ì943.
