PART I.-WORKS.

(A) HYDRO-ELECTRIC GENERATION WORKS IN THE COUNTY OF ARGYLL.

Work No. 1.—A reservoir in the Parishes of Killean and Kilchenzie and Campbeltown to be formed by a dam across the Strathduie Water at a point approximately 190 yards north-east of the junction of the Allt Harvie and the Strathduie Water.

Works Nos. 2, 3, and 4.-Aqueducts in the Parish of Campbeltown.

Work No. 5.-An aqueduct in the Parish of Killean and Kilchenzie.

Work No. 6.—A generating station in the Parish of Campbeltown situated at the termination of Work No. 2 at a point approximately 160 yards north of West Laggan Farm and including a tailrace to the Glen Lussa Water.

Work No. 7.--A diversion in the Parish of Killean and Kilchenzie of the public road to Gobagrenan and Strathduie Water.

(B) ELECTRICITY TRANSMISSION LINES IN THE COUNTY OF ARGYLL.

(a) Two single circuit three-phase overhead lines commencing in the Parish of Campbeltown at the generating station (Work No. 6) and terminating in the Burgh of Campbeltown at the existing diesel generating station of the Campbeltown and Mid-Argyll Electric Supply Company Limited.

(b) One single circuit three-phase overhead line commenc-ing at the said diesel generating station then through the Parishes of Campbeltown, Saddell, Skipness, and Kilcalmonell and terminating at a point near Tarbert in the Parish of South Knardel South Knapdale.

(c) One single circuit three-phase overhead line commenc-ing at the said diesel generating station then through the Parish of Killean and Kilchenzie terminating at a point near the Village of Whitehouse in the Parish of Kilcalmonell.
