RECRUITMENT UNDER NORMAL REGULATIONS OF ASSISTANT EXPERIMENTAL OFFICERS IN VARIOUS GOVERNMENT DEPART-MENTS.

1. There will be three Methods of entry, Method I., Method II., and Method III., but a candidate may apply to compete by one Method only in this competition: Regulations 2 and 3 relate to Method I., Regulations 4 and 5 to Method II., and Regulations 6 and 7 to Method III.; the remaining Regulations relate to all three Methods.

METHOD I.

2. Eligibility.

(i.) Candidates must be at least 174 years and under 184 years of age on 1st August 1948, i.e., they must have been born on or after 2nd February 1930 and on or before 1st February 1931.

(ii.) No specific educational qualifications are required of candidates competing under Method I.

3. Subjects of Examination.

(i.) The examination consists of :---

A candidate must take two optional subjects, and a candidate who takes Biology may not also take either Botany or Zoology.

METHOD II.

4. Eligibility.

(i.) This method of entry is restricted to candidates who are ineligible for Method I. (Regulation 2 above) and

(a) will have completed their period of compulsory service in H.M. Armed Forces under the National Service Acts not later than 1st August, 1948; and (b) after deducting such period of service from their actual age at 1st August 1948, would be under 18½ years of

age at that date.

(ii.) No specific educational qualifications are required of candidates competing under Method II.

5. Subjects of Examination.

(i.) The examination consists of :--

METHOD III.

6. Eligibility.

(i.) Age.—Candidates must be at least 20 years and under 26 years of age on 1st August 1948, i.e., they must have been born on or after 2nd August 1922 and on or before 1st August 1928. But a candidate who has served or is serving on a regular or short service engagement in H.M. Forces may for this purpose deduct his period of such service from his actual age.

(ii.) Education.-Every candidate must either

(a) have obtained a university degree in a scientific or

(b) have obtained associateship of the Royal Institute of Chemistry or graduate membership of any other professional institution accepted by the Commissioners as appropriate, or

(c) have obtained the Higher National Certificate, or (d) have obtained the Higher School Certificate, with Mathematics or a science subject as a principal subject, or an equivalent qualification.

(c) Candidates not in possession of such a certificate or equivalent qualification may be admitted by the Commis-sioners, at their discretion, if they can produce evidence of suitable experience : such candidates currently serving in a Government Department must be certified by that Department as being worthy of consideration.

7. Competition.

(i.) The Commissioners may at their discretion summon

(ii) The commissioners may at other discretion similar candidates to a preliminary informal interview.
(iii.) A certain number of the candidates will be chosen on the basis of the information available, to appear before a Selection Board appointed by the Commissioners.
(iii.) The decision of the Commissioners will be final.

THE FOLLOWING REGULATIONS RELATE TO ALL THREE METHODS.

8. Sex and Marriage.

(i.) Both men and women may compete under these Regulations.

(ii.) Married women who have formerly been established (11.) Married women who have formerly been established civil servants and are appointed under these Regulations to situations in certain Departments which render them eligible for pension and other benefits under the Superannuation Acts, and have drawn marriage gratuity (other than those who are widows or divorced, or who are separated from their hus-bands, or whose husbands suffer without hope of recovery from total physical or mental incapacity) will not be eligible unless they undertake to refund on appointment the marriage gratuity naid. gratuity paid.

9. Nationality.

Candidates must be British subjects. They must also satisfy one of the following conditions :-

(a) If natural-born British subjects, they must either

(i.) have at least one parent who is or was at death a (ii.) have resided in His Majesty's dominions and/or

been employed elsewhere in the service of the Crown for at least five years out of the last eight years preceding the date of their appointment.

(b) If naturalized British subjects, they must have re-sided in His Majesty's dominions and/or been employed elsewhere in the service of the Crown for at least five years out of the last eight years preceding the date of their annument that the service of the appointment.

(c) If not qualified under (a) or (b) of this paragraph they must satisfy the Commissioners that they are so closely connected with His Majesty's dominions either by ancestry, upbringing, or residence, or by reason of national service, that an exception may properly be made in their favour.

Provided that a candidate will not be eligible for an ap-pointment under the Admiralty, War Office, Air Ministry, or Ministry of Supply, unless he or she is a natural-born British subject and born within the United Kingdom or in one of the self-governing Dominions of parents also born within the United Kingdom or in one of the self-governing Dominions, except when the circumstances are such as to institute for the self-governing born in which core for the self-governing Dominions, except when the circumstances are such as to justify a departure from the general rule, in which case, pro-vided the candidate satisfies the conditions prescribed by the preceding paragraphs, he or she may be admitted by special permission of the First Lord of the Admiralty, Secretary of State for War, Secretary of State for Air, or Minister of Supply, as the case may be.

10. Health and Character.

Successful candidates must satisfy the Commissioners as to their health and character.

11. Candidates trained as teachers.

Pers ns upon whose training for the occupation of teacher public money has been spent cannot be appointed until the consent of the appropriate central education authority (e.g., the Ministry of Education, the Scottish Education Depart-ment, the Ministry of Education for Northern Ireland) has been notified to the Commissioners.

12. Assignment.

It will rest with the Commissioners to determine the Department to which each successful candidate shall be assigned. In making the assignments the Commissioners will be guided by the requirements of the public service but the wishes of candidates will be met as far as possible.

13. Canvassing.

Any attempt on the part of candidates to enlist support for their applications through Members of Parliament or other influential persons, except as referees to be named by them in their Application Forms, will disqualify them for appointment.

14. Fee.

A fee of 10s. is payable by all candidates. This must be sent with the application form, and is not returnable in any circumstances.

15. These regulations apply to the Competition of 1948. For subsequent competitions the regulations will be similar, except for the governing date for age in Regulations 2, 4, and 6; this will be the 1st August of the year in which the competition is held.

These regulations are issued by the Civil Service Commis-sioners with the approval of the Treasury and are liable to alteration from time to time.
