EXPLANATORY NOTE. These regulations contain various modifications of the National Insurance Act, 1946, for the purposes of retirement pensions and widow's benefit, principally in relation to persons who on the appointed day (5th July 1948) are over the age of sixteen and under pensionable age and who do not come within the scope of the existing Contributory Pensions Acts.
