

Statutory Instruments 1948, No. 1340. MERCHANT SHIPPING. LIGHT DUES.

THE MERCHANT SHIPPING (LIGHT DUES) ORDER,

1948, made 22nd June 1948; coming into Operation upon the date of publication in the London Gazette (25th June 1948).

PRESENT.

The KING's Most Excellent Majesty in Council.

WHEREAS by Section 5 of the Merchant Shipping (Mer-cantile Marine Fund) Act, 1898 (61 & 62 Vict., c. 44) hereinafter referred to as "the said Section "), it is, amongst

hereinafter referred to as "the said Section "), it is, amongst other things enacted as follows :— "5.—(1) On and after the commencement of this Act the general lighthouse authorities shall levy light dues with respect to the voyages made by ships or by way of periodical payment, and not with respect to the lights which a ship passes or from which it derives benefit, and the dues so levied shall take the place of the dues now levied by those authorities levied by those authorities.

(2) The scale and rules set out in the Second Schedule to this Act shall have effect for the purpose of the levying of light dues in pursuance of this Act, but Her Majesty may, by Order in Council, alter, either generally or with respect to particular classes of cases, the scale or rules and the arcmetions therefore " exemptions therefrom."

And whereas by the Merchant Shipping (Light Dues) Order, 1947 (S.R. & O. 1947, No. 1516), certain alterations were made in the Scale and Rules set out in the Second

Schedule to the said recited Act : And whereas it is expedient that such last recited Order should be revoked :

And whereas it has been made to appear to His Majesty that the said Scale and Rules should be further altered in

manner hereinafter appearing: Now, therefore, His Majesty, in exercise of the powers vested in Him by the said Section and of all other powers enabling Him in that behalf, is pleased, by and with the advice of His Privy Council, to order, and it is hereby ordered as follows:—

ordered as follows:-1.-(a) This Order shall come into operation on the date of its publication in the London Gazette (25th June 1948), and may be cited as the Merchant Shipping Light Dues) Order, 1948. (b) The Interpretation Act, 1889 (52 & 53 Vict., c. 63), shall apply to the interpretation of this Order as it applies to the interpretation of an Act of Parliament. 2. Each of the dues authorised to be levied in accordance with the Scale set out in the Second Schedule to the said recited Act shall be subject to an increase of 300 per cent., for the purposes of the levving of light dues in pursuance of

3. The payments referred to in the proviso to Rule (1) and in the proviso to Rules (7) of the Rules set out in the Second Schedule to the said recited Act shall also be subject to an increase of 300 per cent.

TENDERS FOR TREASURY BILLS.

5. Tenders must be made through a London Banker, Discount House, or Broker.

6. The persons whese Tenders are accepted will be informed of the same not later than the following day and payment in full of the amounts of the accepted Tenders must be made to the Bank of England by means of Cash or a Banker's Draft on the Bank of England not later than 1.30 p.m. (Saturday, 12 noon) on the day on which the relative Bills are to be dated dated.

7. Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.

1. Age.

Candidates must be at least 17½ and under 18½ years of age (a half-year equals six calendar months) on the governing date for age. For an examination held in the first six months of any year the governing date will be the 1st March in that year; for an examination held in the last six months of any year it will be the 1st September in that year.

2 - Sex.

Both men and women are eligible, but women will not ordinarily be appointed to posts in the Admiralty, War Office, or Air Ministry, or to the Immigration Service of the Home Office.

3. Nationality.

Candidates must be British subjects. satisfy one of the following conditions :---They must also
