BOARD OF TRADE ANNOUNCEMENT. SAFEGUARDING OF KEY INDUSTRIES.

The attention of traders is drawn to the Safeguarding of Industries (List of Dutiable Goods) Order, 1948 (S.I. No. 1826), published by the Board of Trade, which will take effect on the 20th August 1948. Copies may be obtained from H.M. Stationery Office, price 2d. net.

The Order introduces an additional list of articles liable to duty under Part 1 of the Safeguarding of Industries Act, 1921, being articles falling within the scheduled heading relating to synthetic organic and other fine chemicals.

Amendments to lists H, H(ii.), H(iii.), and H(v.) are also made by this Order. The effect of these amendments is to remove redundant or obsolete items, to make all grades of carbon bisulphide and potassium permanganate liable to

of carbon bisulphide and potassium permanganate liable to Key Industry Duty, to sub-divide two items for statistical purposes and to introduce the modern spelling of certain chemical descriptions.

chemical descriptions.

This Order should read in conjunction with the Safeguarding of Industries (Exemption) (No. 7) Order, 1948 (S.I. No. 1811) and the Safeguarding of Industries (Reduction of Rates) Order, 1948 (S.I. No. 1815), notice of which is given on page 357 of this issue. The latter Order reduces the Key Industry Duty rate chargeable on four of the items in the new additional list, in accordance with the tariff commitments entered into in the General Agreement on Tariffs and Trade, 1947.
