And whereas the said John Millar Matthew cannot, in my opinion, properly be allowed to be in possession of or to supply any drug or preparation to which the Dangerous Drugs Regulations, 1937, or any drug to which the Raw Opium, &c., Regulations, 1937, apply:

Now therefore, in pursuance of the powers conferred on me by Regulation 7 of the Dangerous Drugs Regulations, 1937, and by Regulation 5 of the Raw Opium, &c., Regulations, 1937, I hereby withdraw from the said John Millar Matthew the authorities conferred by the said Regulations upon him to be in possession of and to supply the drugs or preparations to which the Dangerous Drugs Regulations, 1937, and the drugs to which the Raw Opium. &c., Regulations, 1937, apply:

And I hereby direct that it shall not be lawful for the said John Millar Matthew to give prescriptions for the purposes of the Dangerous Drugs Regulations, 1937.

FACTORIES ACTS, 1937 AND 1948.

In pursuance of Section 129 of the Factories Act, 1937, and the second Schedule to that Act, the Minister of Labour and National Service hereby gives notice that he proposes to make Special Regulations under Sections 46 and 60 of the Act applying (subject to certain exceptions) to factories in which the manufacture or decoration of pottery is carried on or in which, for use in the manufacture or decoration of pottery, lithographic transfers, frits, or glazes are made, or flint or quartz is ground or powdered, or ground or powdered flint or quartz is mixed with clay or other material to form the body of the ware. The proposed Special Regulations, which are entitled the Pottery (Health and Welfare) Special Regulations, 1949, are intended to supersede the Regulations of 1913 for the Manufacture and Decoration of Pottery, and the Pottery (Silicosis) Regulations, 1932, but not the Pottery (Health) Special Regulations, 1947.

The Civil Service Commissioners hereby give notice that the following Regulations are published with the approval of the Lords Commissioners of His Majesty's Treasury, viz.:—

RECRUITMENT UNDER NORMAL REGULATIONS TO THE STATISTICIAN CLASS.

1. No candidate may compete more than twice in all under

Normal and Reconstruction Regulations.

2. Age. Candidates must (save as provided below) be at least 20½ years and under 24 years of age on the 1st day of August 1949. But

(a) a candidate who has served or is serving on a regular (including a regular short service) engagement in H.M. Forces may deduct the period of such service from his

actual age;) a candidate who has served or is serving voluntarily (b) a candidate who has served or is serving voluntarily in H.M. Forces otherwise than on a regular or short service engagement or who has performed or is performing compulsory national service under the National Service Acts may deduct the period of such service from his actual age, up to a maximum of two years.

3. Sex. Both men and women may compete under these Regulations.

4. Nationality. Candidates must be British subjects. They must also satisfy one of the following conditions:—

(a) If natural-born British subjects, they must either

(i) have at least one parent who is or was at death a British subject, or

(ii) have resided in His Majesty's dominions and/or been employed elsewhere in the service of the Crown for at least five years out of the last eight years preceding the date of their appointment.

(b) If naturalized British subjects, they must have resided in His Majesty's dominions and/or been employed elsewhere in the service of the Crown for at least five years out of the last eight years preceding the date of their appointment.

(c) If not qualified under (a) or (b) of this paragraph they must satisfy the Commissioners that they are so closely connected with His Majesty's dominions either by ancestry, upbringing or residence, or by reason of national service, that an exception may properly be made in their

and Character. Successful candidates must satisfy the Commissioners as to their health and character.

6. Subjects of Examination. (i) The examination consists of the following :-

(A) A written examination comprising

(a) five compulsory subjects for which a maximum of 700 marks is allotted;

- (b) a selection from the optional subjects set out in the Appendix, which is to be construed as forming part of these Regulations. Subject to the provisions in the Appendix, candidates may take optional subjects up to a total of 300 marks.
- (B) Interview, comprising
- (a) a preliminary interview by a single interviewer who will supply a report for the information of the Final Interview Board;
- (b) an interview before the Final Interview Board, which will award a mark out of a maximum of 300 for the candidate's record, intelligence, and personal qualities.
- (ii) The final order of merit will be determined by the total marks gained in the whole examination. In the event of a tie between two or more candidates, the Commissioners may determine at their discretion which to declare successful.

7. Candidates trained as Teachers. Candidates who have been trained as teachers and upon whose training public been trained as teachers and upon whose training public money has been spent cannot be appointed until the consent of the appropriate central education authority (e.g., the Ministry of Education, the Scottish Education Department, the Ministry of Education for Northern Ireland) has been notified to the Commissioners.

8. Assignment. The Commissioners will decide to which Government Department each successful candidate is to be designed.

assigned. A candidate who declines to accept the post offered will have no claim to be assigned to another, but will be regarded as having declined appointment. Assignments will be made in accordance with the needs of the public service, but the wishes of candidates will, where possible, be taken into account.

9. Canvassing. Any attempt on the part of candidates to enlist support for their applications through Members of Parliament or other influential persons, except as referees to be named by them in their application forms, will disqualify them for appointment.

10. Fee. A fee of £1 is payable by all candidates. This must be sent with the application form.
11. These Regulations apply to the examination of 1949, and are liable to be modified for subsequent examinations. They are issued by the Civil Service Commissioners with the approval of the Treasury.
