#### EXPLANATORY NOTE.

These Regulations provide that a person may, in respect of full-time education or full-time unpaid apprenticeship after full-time education or full-time unpaid apprentices in after the age of eighteen years, pay contributions as a non-employed person under Regulation 7 (2) (c) (i) of the National Insur-ance (Contributions) Regulations, 1948, at any time within a period of approximately four to five years from the termina-tion of the education or apprentices hip. The period varies slightly according to the circumstances of each case.

#### THE FOOD AND DRUGS (WHALEMEAT) REGULATIONS, 1949
