## BY THE KING. A PROCLAMATION

REVOKING A PROCLAMATION, DATED THE 11TH DAY OF JULY 1949, DECLARING THE EXISTENCE OF A STATE OF EMERGENCY FOR THE PURPOSES OF THE EMERGENCY POWERS ACT, 1920.

WHEREAS by virtue of Our Proclamation, dated the eleventh day of July nineteen hundred and forty-nine, We did declare the existence of a state of emergency for the purposes of the Emergency Powers Act, 1920;

And whereas it appears to Us that the state of emergency has now ceased to exist, and that it is expedient that the said Proclamation should be revoked accordingly:

Now, therefore, We, by and with the advice of Our Privy Council, do hereby proclaim, direct, and ordain that the said Proclamation of the eleventh day of July nineteen hundred and forty-nine is revoked.

Given at Our Court at Buckingham Palace, this twenty-sixth day of July in the year of our Lord one thousand nine hundred and forty-nine and in the thirteenth year of Our Reign.

THE WISBECH PILOTAGE ORDER, 1949.

## EXPLANATORY NOTE.

These Regulations amend the National Insurance (Medical Certification) Regulations, 1948, by extending the intervals of time at which a medical certificate in the form of a Special Intermediate Certificate may be given in any case of prolonged incapacity and by enabling such a Certificate to be given even though the claimant is being examined or treated by the doctor at more frequent intervals.
