TENDERS FOR TREASURY BILLS.

- 1. The Lords Commissioners of His Majesty's Treasury 1. The Lords Commissioners of His Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England, on Friday the 30th September 1949, at 1 p.m., for Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, and the National Loans Act, 1939, to the amount of £220,000,000.

- 3. The Bills will be issued and paid at the Bank of England.
- 4. Each Tender must be for an amount not less than £50,000 and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.
- 5. Tenders must be made through a London Banker, Discount House, or Broker.
- 6. The persons whose Tenders are accepted will be informed of the same not later than the following day, and payment

in full of the amounts of the accepted Tenders must be made to the Bank of England by means of cash or a Banker's Draft on the Bank of England not later than 1.30 p.m. (Saturday 12 noon) on the day on which the relative Bills are to be dated.

- 7. Members of the House of Commons are not precluded from tendering for these Bills.
- 8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.
- 9. The Lords Commissioners of His Majesty's Treasury reserve the right of rejecting any Tenders.

REGULATIONS DATED THE 5TH DAY OF SEP-TEMBER 1949 MADE BY THE TREASURY UNDER ARTICLE 6 OF THE ORDER IN COUNCIL DATED THE 22ND DAY OF JULY 1920, WITH RESPECT TO THE PERIOD OF PROBATION TO BE SERVED BY CIVIL SERVANTS.

In the Regulations appearing in the Edinburgh Gazette dated 13th September 1949, paragraph 3 (1), the words: "Regulations dated the 5th day of October 1949" should read "Regulations dated the 5th day of October 1948."

Civil Service Commission, 20th September 1949.

The Civil Service Commissioners hereby give notice that the following Regulations are published with the approval of the Lords Commissioners of H.M. Treasury, viz.:—

RECRUITMENT UNDER NORMAL REGULATIONS OF VETERINARY INSPECTORS, RESEARCH OFFICERS AND ASSISTANT VETERINARY INVESTIGATION OFFICERS IN THE MINISTRY OF AGRICULTURE AND FISHERIES.

- 1. Age .--Candidates must be at least 23 and under 32 years of age on 1st January 1949. But a candidate who has served or is serving on a regular (including a regular short service) engagement in H.M. Forces may for this purpose deduct the period of such service from his actual age.
- 2. Sex and Marriage.—(i) Both men and women may compete under these Regulations.
- (ii) Married women who have formerly been established Civil Servants and have drawn marriage gratuity (other than those who are widows or divorced or who are separated from their husbands, or whose husbands suffer without hope of recovery from total physical or mental incapacity) will not be discible analysis that makes the restriction of the contribution of the c eligible unless they undertake to refund on appointment the marriage gratuity paid.

- 3. Nationality.—Candidates must be British subjects. They must also satisfy one of the following conditions:—
 - (a) If natural-born British subjects, they must either
 - (i) have at least one parent who is, or was at death, a British subject; or
 - (ii) have resided in His Majesty's dominions and or been employed elsewhere in the service of the Crown for at least five years out of the last eight years preceding the date of their appointment.
 - (b) If naturalized Brotish subjects, they must have resided in His Majesty's dominions and/or been employed elsewhere in the service of the Crown for at least five years out of the last eight years preceding the date of their appointment.

(c) If not qualified under (a) or (b) of this paragraph, they must satisfy the Commissioners that they are so closely connected with His Majesty's dominions either by ancestry, upbringing or residence, or by reason of national service, that an exception may properly be made in their favour.

4. Qualification.—(a) Candidates for appointment as Veterinary Inspector must have graduated as Members of the Royal College of Veterinary Surgeons and have had at least one year's practical experience in some recognised branch of

- one year's practical experience in some recognised branch of the veterinary profession after graduation.

 (b) Candidates for appointment as Research Officer or Assistant Veterinary Investigation Officer should normally be Members of the Royal College of Veterinary Surgeons but in exceptional cases this qualification may be dispensed with in view of the special requirements of the Ministry of Agriculture and Fisheries and the special qualifications of a candidate. Preference will be given to those candidates who have had post-graduate experience in laboratory research work or in some other recognised branch of the Veterinary Profession.
- 5. Health and Character.—Successful candidates must satisfy the Commissioners as to their health and character.
- 6. Competition.—The Commissioners may summon to appear before a Selection Board all who are found to be prima facie eligible, or may, if they see fit, summon only those whose qualifications and experience are considered to be most suitable. The Selection Board will take into consideration the candidates' record of experience and education, any recommendation from persons named by the candidates as having direct knowledge of their work, and the personal qualities of the candidates as shown at the interview; and on their estimation of all the above facts they will frame their recommendations. The decision of the Commissioners will be final.
- 7. Candidates Trained as Teachers.—Persons upon whose training for the occupation of teacher public money has been spent cannot be appointed until the consent of the appropriate central education authority (e.g., the Ministry of Education, the Scottish Education Department, the Ministry of Education for Northern Ireland) has been notified to the Commissioners.
- 8. Canvassing.—Any attempt on the part of candidates to enlist support for their applications through Members of Parliament or other influential persons except as referees to be named by them in their Application Forms, will disqualify them for appointment. The Selection Board will disregard recommendations from persons who are not personally acquainted with the candidates' work, whether at school, in the Forces, or otherwise.
- 9. Fee.—A successful candidate will be required to pay a fee of £1 before the issue of a Certificate of Qualification for appointment.

RECRUITMENT UNDER NORMAL REGULATIONS OF RESEARCH OFFICERS AND RESEARCH ASSISTANTS IN THE MINISTRY OF TOWN AND COUNTRY PLANNING.

1. Age.—(i) Candidates for the post of Research Officer must be at least 30 years of age on the 1st August 1949. The Commissioners have not specified an upper age limit for this situation; in general, however, Government Departments re-

- quire a reasonable period of service from persons newly appointed to the Civil Service, and accordingly the Commissioners reserve the right to give weight to this factor in considering candidates who are over 50 years of age.
- (ii) Candidates for the post of Research Assistant must be at least 21 and under 30 years of age on the 1st August 1949. But
 - (a) a candidate who has served or is serving on a regular (including a regular short service) engagement in His Majesty's Forces may for this purpose deduct the period of such service from his actual age;
- (b) a candidate who has served or is serving voluntarily in His Majesty's Forces otherwise than on a regular or short service engagement or who has performed or is performing compulsory national service under the National Service Acts may deduct the period of such service from his actual age, up to a maximum of two years.
- 2. Sex.—Both men and women may compete under these Regulations.
- 3. Nationality.—Candidates must be British subjects. They must also satisfy one of the following conditions:—
 - (a) If natural-born British subjects, they must either:
 - (i) have at least one parent who is or was at death a British subject; or
 - (ii) have resided in His Majesty's dominions and/or been employed elsewhere in the service of the Crown for at least five years out of the last eight years preceding the date of their appointment.
- (b) If naturalised British subjects, they must have resided in His Majesty's dominions and or been employed elsewhere in the service of the Crown for at least five years out of the last eight years preceding the date of their appointment.

For one post preference will be given to candidates having research experience on geological resources.
