In paragraph (3) (a) of Article 22 of the Order in Council dated the 29th September 1949 (as so amended) there shall be inserted after the words "In the Table in the Second Schedule to the 1921 (Officers) Order" the words "for the figures £600, £450, £375, £300, £260, £220 and £200 in column (4) there shall be substituted the figures £700, £540, £440, £350, £280, £230, and £210 respectively; for the figures £600, £450, £375, £300. £240, £180, and £162 in column (5) there shall be substituted the figures £700, £540, £440, £350, £290, £230, and £210 respectively;". 2. 
