Statutory-Instruments 1950, No. 516. BURIAL, SCOTLAND. DISCONTINUANCE.

THE BURIAL GROUNDS (SCOTLAND) (OLD BURIAL GROUND, GLENELG) ORDER, 1950, made 31st March

At the Court at Windsor Castle, the 31st day of March 1950. PRESENT,

The KING's Most Excellent Majesty in Council.

WHEREAS the Secretary of State for Scotland has, in WHEREAS the Secretary of State for Scotland has, in pursuance of the powers competent to him under the Burial Grounds (Scotland) Act, 1855 (18 & 19 Vict., c. 68), made a Representation that he has received a copy of an Interlocutor dated 20th September 1949 pronounced by the Sheriff Substitute of Inverness, Moray, Nairn, and Ross and Cromarty, at Inverness, finding that the former burial ground of the Parish of Glenelg, known as the Old Burial Ground, Glenelg, being the Churchyard attached to the Church in Kirkton Village in the Parish of Glenelg, is in a condition which is dangerous to health and contrary to decency:

And whereas in the saud Representation it is recommended

And whereas in the said Representation it is recommended that burials be forthwith discontinued in the said Burial Ground in terms of Section 5 of the aforesaid Act except in

the cases hereinafter specified :

And whereas by an Order in Council of the 21st day of December 1949 Notice of such Representation was given and it was ordered that the same should be taken into consideration by a Committee of the Privy Council on the 9th day of February 1950, and that the said Order, or Notice thereof, should be published in the Edinburgh Gazette and that copies of the said Order, or Notice thereof, should be fixed on the doors of the church of or on some other conspicuous places within the Parish of Glenelg one month before the said 9th day of February 1950:

And whereas Notice of the said Representation and of the time when it pleased His Majesty to order the same to be taken into consideration by the Privy Council has been duly published in the Edinburgh Gazette and fixed in manner required by the said Order in Council:

Now, therefore, His Majesty, by and with the advice of His Privy Council, is pleased to order, and it is hereby ordered, as follows, viz.:—

1. That, in terms of Section 5 of the Burial Grounds

1. That, in terms of Section 5 of the Burial Grounds (Scotland) Act, 1855, burials be forthwith discontinued in the former burial ground of the Parish of Glenelg, known as the Old Burial Ground, Glenelg, being the Churchyard attached to the Church in Kirkton Village in the Parish of Glenelg and County of Inverness, except in the cases of—

(1) Persons whom the County Council of the County of Inverness may specially authorize to be buried in the said Burial Ground; and
(2) Cremated human remains:

Provided that such burial be not injurious to health or offensive or contrary to decency, that Notice be given to the

District Sanitary Inspector not later than a day preceding that on which a grave is to be opened, and that no burial except the burial of cremated human remains shall be made except the burial of cremated human remains shall be made unless the coffin can be laid at a depth of four feet from the surface of the ground to the upper surface of the coffin and that without interference with the remains of a previous burial.

2. This Order may be cited as the Burial Grounds (Scotland) (Old Burial Ground, Glenelg) Order, 1950.

The Lords Commissioners of His Majesty's Treasury hereby announce that They have made an Order under Section 21 of the Finance Act, 1948, replacing Purchase Tax (No. 7) Order, 1949 (S.I. 1949, No. 2443), and revising the classification of greeting cards for purchase tax purposes. Apart from greeting cards, all articles affected by the Purchase Tax (No. 7) Order, 1949, revert to the rates obtaining prior the operation of that Order. As regards greeting cards the new Order provides a new line of demarcation between the kinds chargeable at 33\frac{1}{3} per cent. and those chargeable at 100 per cent. Broadly the 33\frac{1}{3} per cent. rate will continue to apply to the simpler kinds of cards.
