The Secretary of State for Scotland, in exercise of his powers under the Destructive Insects and Pests Acts, 1877 to 1927, has made the Importation of Raw Cherries (Scotland)

powers under the Destructive Insects and Pests Acts, 1877 to 1927, has made the Importation of Raw Cherries (Scotland) Order, 1950, imposing restrictions on the importation of raw cherries from European countries into Scotland during that period of the year when there is danger of the introduction of the Cherry Fruit Fly.

From 19th May the importation of cherries grown in Spain is prohibited; cherries grown in Italy, Austria, Bulgaria, Hungary, Switzerland, and Portugal will be admitted up to specified dates and cherries from France and Germany during the whole period the Order is in operation, subject to each consignment being certified as prescribed in the Order; cherries from other European countries will be admitted after 18th May provided that each consignment is accompanied by a certificate of origin.

The Order, which comes into operation on 19th May and will remain in force until 30th September 1950, does not apply to raw cherries grown in England or Wales, Northern Ireland, the Republic of Ireland, the Isle of Man, or the Channel Islands.
