RECRUITMENT UNDER NORMAL REGULATIONS OF SECOND AND THIRD CLASS VALUERS IN THE INLAND REVENUE.

1. Candidates must (save as provided below) be at least 25 and under 35 years of age on the 1st May 1950.

But, exceptionally for the year 1950, candidates who are 35 years of age or over on that date will be eligible, without any upper age limit. In general, however, Government Depart ments require a reasonable period of service from persons newly appointed to the Civil Service, and accordingly the Commissioners reserve the right to give weight to this factor in considering candidates for these posts who are over 50 years of age. of age.

2. (i) Bot Regulations. Both men and women may compete under these

(ii) Married women who have formerly been established (ii) Married women who have formerly been established civil servants and have drawn marriage gratuity (other than those who resigned compulsorily on marriage and whose resignation took effect before 15th October 1946, or who are widows or divorced, or who are separated from their husbands, or whose husbands suffer without hope of recovery from total physical or mental incapacity) will not be eligible unless they undertake to refund on appointment the marriage gratuity paid.

(c) If not qualified under (a) or (b) of this paragraph they must satisfy the Commissioners that they are so closely connected with His Majesty's dominions either by ancestry, upbringing or residen e, or by reason of national service, that an exception may properly be made in their favour

4. Candidates must have pa sed the Final Examination of the Royal Linstitution of Chartered Surveyors, or of the Chartered Auctioneers' and Estate Agents' Institute, or of the Land Agents' Society, or hold a University Degree (e.g., B Sc Estate Management) London, or B.A. (Estate Management Cambridge) which gives exemption from the examinations of any one of these bodies. Candidates who are sitting their final examination in Spring or Summer, 1950, may submit previsional applications on the understanding that they will be

declared ineligible if hey fail to pass the examination. All candidates must, on the closing date for the receipt of applications, have had at least four years' professional experience before or after qualifying in :-

Candidates for vacancies in Scotland should preferably have had Scottish experience.

5. Successful candidates must satisfy the Commissioners as to their health and character.

6. Every candidate must apply on the appropriate form within the time and in the manner of which notice is given

- by the Commissioners.

Those candidates who appear from their application forms to have the best qualifications will be summoned to an interview before a Selection Board which will recommend to interview before a Selection Board which will recommend to the Commissioners for appointment the candidates who appear to them to be most suitable. The Board will take into consideration the candidates' record of education and experience, any recommendations that they may receive from persons named by the candidates as having direct knowledge of their work in the past, and the personal qualities of the candidates as shown at the interview, and on their estimation of the above evidence they will frame their recommendations. When the Board recommend a candidate to a post for the valuation of minerals in England and Wales, they will recommend him for appointment as Second Class or Third Class Valuer according to his qualifications and experience. The decision of the Commissioners will be final.
